<p>1 Can you please me send a copy, electronic if that is possible, of the winning bids from the 2016 Receipt, Storage, and Distribution of USDA Commodity Foods bid for regions 2, 3, 4, and 5?</p>	<p>The base year of the current contracts was fiscal year (FY) 2013, with 4 options to renew. The State is accommodating this request by providing scanned copies of technical proposals from the winning FY13 bids for regions 2, 3, 4, and 5, with personal and sensitive information redacted. The winning cost proposals for these 4 regions are summarized on one page. This winning technical proposal and cost information is posted on the internet as "Amendment 1 Attachment A" on the same site as the RFP and Amendment 1.</p>
<p>2 In the event a different distributor wins the contract for this RFP, will the current distributor continue to deliver any remaining inventory until exhausted? If not, how is that scenario handled?</p>	<p>Item E.7. "Transfers," found in the RFP's pro forma contract, matches the current contract language regarding transfers. If the current contractor isn't the successful bidder for the new contract, the current contractor will be responsible for transferring remaining inventory of USDA commodity foods to the new contractor at the new contractor's expense. Foods will be transferred at the lump-sum price specified in the current contract.</p>
<p>3 What is the current region 3 delivery cost per case to recipient kitchens? What is the current region 3 lump-sum cost per case to warehouses? What were the per case delivery costs for both kitchens and warehouse deliveries for the previous 4 school years?</p>	<p>See item 1 above. Amendment 1 Attachment A includes a summary of cost information for regions 2, 3, 4, and 5. The current costs for region 3 are the same as the costs in the previous 4 school years.</p>
<p>4 What counties are warehouse deliveries only?</p>	<p>We are not aware of any recipient agencies in region 3 that are warehouse delivery only.</p>
