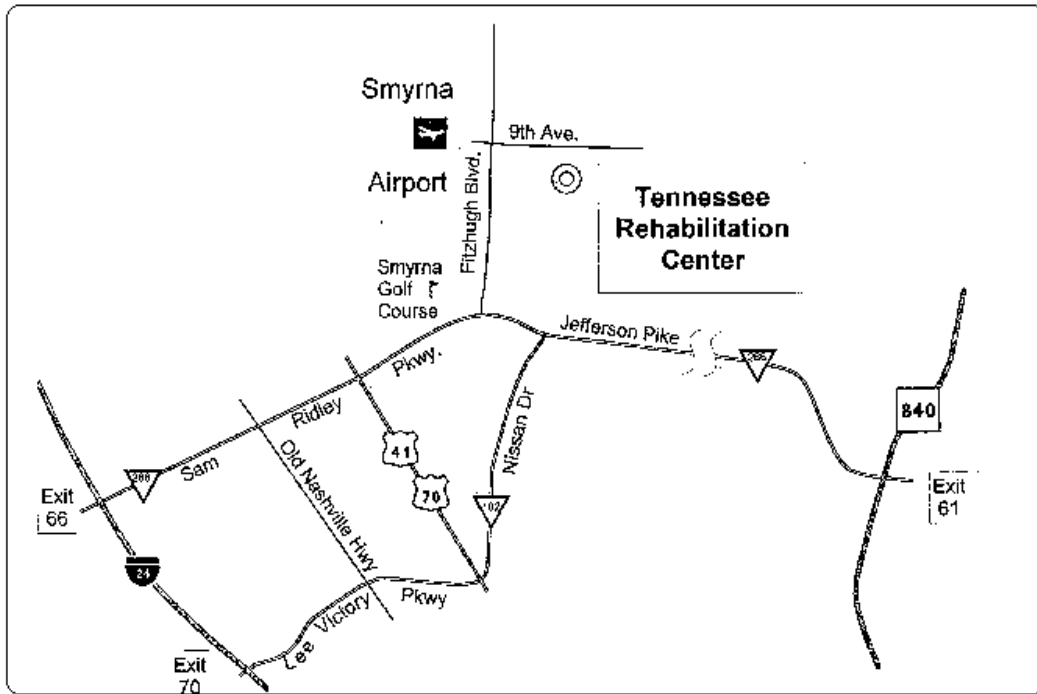

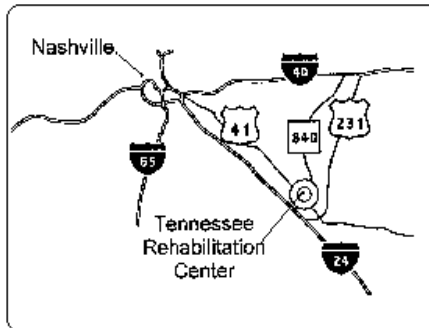

*Student Government Hall is off the cafeteria in the building next to A building. When you walk in from visitor parking you take a left and it's the building immediately on your right.



From I-40 take Exit 235 onto Tennessee 840 West. From TN-840 west, take Smyrna Exit 61. Turn right on State Route 266 (Jefferson Pike). Go to the end of Jefferson Pike where there will be a red light (it is several miles). Turn right, then go to Fitzhugh Boulevard which will be on your right (there is a sign that says Smyrna Airport there also). Go straight until you get to 9th Avenue, turn right and then you will see a green sign that says Tennessee Rehabilitation Center, there are also flag poles in front of the Administrative Building. Park there and go to the front desk where the receptionist will be.



From I-24 take Exit 66, Sam Ridley Parkway. Go straight for approximately 3 miles. Turn left onto Fitzhugh Boulevard (there is a sign that says Smyrna Airport there also). Go straight until you get to 9th Avenue, turn right and then you will see a green sign that says Tennessee Rehabilitation Center, there are also flag poles in front of the Administrative Building. Park there and go to the front desk where the receptionist will be.

Directions to Tennessee Rehab Center, Smyrna, TN

From I-24

Take the **TN-266 E/Sam Ridley Pky** exit, **EXIT 66B**, toward Smyrna. 0.3 mi
Merge onto **TN-266/Sam Ridley Pkwy W**. 4.2 mi
Turn left onto **Fitzhugh Blvd**. 0.6 mi
(Look for the Smyrna Airport sign)
Turn right onto **9th Ave**.

From Knoxville

From I-40, merge onto **TN-840 W** via **EXIT 235** toward **Murfreesboro** 15.8 mi
Take the **TN-266** exit, **EXIT 61**, toward **Smyrna** 0.4 mi
Turn Right on **W Jefferson Pike / TN- 266** 3.6 mi
Turn right onto **Sam Ridley Pkwy E / TN-266** 0.8 mi
Turn right onto **Fitzhugh Blvd** 0.6 mi
(Look for the for Smyrna Airport)
Turn right onto **9th Ave**. 0.4 mi.

From Memphis

(Note: The route via 840 is approx. 12 miles longer than going into Nashville and out I-24, but will allow you to avoid driving in morning traffic.)

From I-40, take **TN-840** via **Exit 176** toward **Franklin** 46.8 mi
Take the **TN 102/ Almaville Rd.** exit, **EXIT 47** 0.4 mi
Turn left onto **Almaville Rd / TN-102**. 12.4 mi
TN-102 becomes **Sam Ridley Pkwy E/ TN-266** 0.8 mi
Turn right onto **Fitzhugh Blvd** 0.6 mi
(Look for the Smyrna Airport sign)
Turn Right onto **9th Ave**. 0.02 mi

There are flag poles in front of the Administration building.

Park there or across the street.

Go to the front desk receptionist. We are meeting in room A-100.
