It appearing to the Court that the defendant currently holds a valid handgun carry permit issued by the State of Tennessee pursuant to Tennessee Code Annotated §39-17-1351 and that:

\_\_\_\_\_ the defendant has been arrested and charged with burglary, a felony drug offense, or a felony offense involving violence or the use of a firearm and is required to surrender said permit pursuant to T.C.A. §39-17-1352(e)(1);

\_\_\_\_\_ the defendant has been arrested and charged with a felony offense other than burglary, a felony drug offense, or a felony offense involving violence or the use of a firearm, and has not petitioned the Court for a hearing on surrender, and is required to surrender said permit pursuant to T.C.A. §39-17-1352(e)(2)

\_\_\_\_\_ the defendant has been arrested and charged with a felony offense other than burglary, a felony drug offense, or a felony offense involving violence or the use of a firearm and has petitioned the Court for a hearing on surrender, the Court has conducted said hearing and has found that the defendant will present a material risk or physical harm to the public if allowed to retain the permit, and the defendant is required to surrender said permit pursuant to T.C.A. §39-17-1352(e)(2);

\_\_\_\_\_ the defendant has been arrested for a class A misdemeanor offense of \_\_\_\_\_ Domestic Violence, \_\_\_\_\_ Stalking or \_\_\_\_\_ DUI 2<sup>nd</sup> offense pursuant to T.C.A §39-17-1351(c)(7) and T.C.A. §39-17-1352(a)(3) & (6)
