REGULATORY BOARDS DISCIPLINARY ACTION REPORT, JUNE 2009

Tennessee Code Annotated, Section 56-1-302(a)(9) requires the Department of Commerce and Insurance to issue a monthly press release containing a disciplinary report which shall list all disciplinary actions taken by each board during the prior month. Below is a list of actions taken during the month June 2009.

Violation: Price lists and Statement of Funeral Goods and Services Selected show an establishment name different than the name registered with the Board, failure to retain a cremation authorization form in the file, failure to maintain a copy of the license and the latest inspection report of the crematory that the establishment uses, price for embalming listed on the General Price List is inconsistent with the amount charged on the statements, prices on the General Price List for direct cremation, immediate burial, range for caskets and range for outer burial containers are inconsistent and Outer Burial Container Price List lacked required disclosure

- Violation: While acting as the manager and in responsible charge of an establishment, the respondent executed a funeral purchase contract that included a specific casket for viewing and cremation and unbeknownst to the family and contrary to the purchase agreement, removed or caused the deceased human remains to be removed and caused the remains to be transported to the crematory for cremation on a mortuary cot, later executed a funeral purchase contract with a separate family that included a different casket but respondent placed the latter remains in the same casket previously purchased for the viewing and cremation of the first deceased individual and subsequently buried the latter deceased in this same casket.
- Action:Suspension of licenses both as a funeral director and embalmer for the period of one (1) year, \$2,000 Civil Penalty, \$1,300 Investigatory Costs, \$230 Hearing Costs and in the event the Respondent is found to engage in any act or conduct that constitutes funeral directing or embalming with this State during the effective period of suspension, both his funeral director and embalmer licenses shall be automatically revoked

Violation: An advertisement was placed in a local paper in which an unlicensed individual was listed as a funeral director
