Re: Waiver for English Language Arts (ELA) Curriculum

Dear Director Murrell:

I am in receipt of your April 5, 2023 waiver request to use the CommonLit Language Arts Curriculum for grades 9-12 for the remainder of the ELA Adoption Cycle (the 2025-26 school year).

Pursuant to state law, the State Board of Education (SBE) is the entity that approves textbook and instructional materials waivers. Chapter 770 of the Public Acts of 2020 transferred authority for issuing textbook and instructional materials waivers from the Tennessee Department of Education (TDOE) to the SBE. Chapter 471 of the Public Acts of 2021 further refined this law. In addition, SBE rule 0520-01-18 lays out the waiver application and review process.

Because the SBE rule requires waiver requests be submitted to the SBE no later than March 15th of the local adoption year, your district will need a waiver of SBE Rule 0520-01-18-.02(3) (a)-(c). This waiver will allow you to submit an emergency waiver request to the SBE. Here is a link to the SBE Guidance on Textbook and Instructional Materials Waivers that includes information about the waivers the department can provide for this process.

Tenn. Code Ann. § 49-1-201(d) grants the commissioner the authority to "waive any state board rule or statute that inhibits or hinders the LEA's ability to meet its goals or comply with its mission." Considering the above, Blount County Schools is hereby granted a waiver of SBE Rule 0520-01-18-.02(3) (a)-(c) to allow your district to submit an emergency Textbook and Instructional Materials Waiver Application to the SBE.

Local Education Agency Waiver Request

Pursuant to Tennessee Code Annotated § 49-1-201(d), upon application by the local education agency for one (1) or more of its schools, the commissioner of education may waive any state board rule or statute that inhibits or hinders the LEA's ability to meet its goals or comply with its mission. Please submit completed forms to Commissioner.Schwinn@tn.gov. Following review by the commissioner, the district will be notified in writing if the waiver request is approved or denied. Unless otherwise stated, all waivers granted by the commissioner shall be granted for one year terms.

Waivers may **not** be granted by the commissioner for regulatory or statutory requirements related to:

- (A) Federal and state civil rights;
- (B) Federal, state and local health and safety;
- (C) Federal and state public records;
- (D) Immunizations;
- (E) Possession of weapons on school grounds;
- (F) Background checks and fingerprinting of personnel;
- (G) Federal and state special education services;
- (H) Student due process;
- (I) Parental rights;
- (J) Federal and state student assessment and accountability;
- (K) Open meetings;
- (L) Educators' due process rights;
- (M) Reductions in teachers' salaries;
- (N) Employee rights, salaries and benefits; and
- (O) Licensure of employees.

Thank you for reaching out to Blount County Schools to gain more clarity around which ELA textbooks we are currently using in each of our schools. After receiving your email and feedback on Thursday, I reached out to the former Assistant Director of Academics, Secondary Instructional Supervisor and ELA coach who were involved in the ELA Textbook Adoption cycle conducted over the course of the 2019-2020 school year to learn more about the adoption and if there were any waivers submitted. From my research, I was able to locate an email communication from the Assistant Director, Dr. Lisa Coons and Virginia Mayfield that gave Blount County Schools permission to continue to implement a pilot program with CommonLit 360 for grades 9-12. A copy of the email has been attached. To ensure that we are in compliance, Blount County Schools is currently in the process of seeking a waiver to continue to use CommonLit 360 for grades 9-12. The CommonLit 360 curriculum is aligned to Tennessee State Standards and does not violate state law. Please feel free to contact me if you have any questions or need additional information.

Good morning,

Thank you for taking the time to fill out the Comptroller's ELA Compliance Review in January of this year. Tennessee law (T.C.A. 49-1-905) requires our office to review the ELA textbooks in use by school districts.

After reviewing the information you provided in the questionnaire, I wanted to confirm that our information is correct. Your response indicated that your district uses "CommonLit 360" in grades 9 and 10, and no textbook titles were provided for grades 11 and 12. Based on your response, I have the following information:

For grades 9-10, the district indicated using textbooks that are not on the 2019 adoption list, and the district does not have an approved waiver to do so. For grades 11-12, the district indicated that they are not using the textbooks they adopted and does not have a waiver for textbooks not on the adoption list.

Can you confirm if this information is correct? If not, can you provide further clarification?

As requested, I will amend our original form with the information for our Wit and Wisdom waiver, which was granted earlier this year for our elementary level.
