I am in receipt of your January 24, 2024 request for a waiver of Tenn. Code Ann. § 49-6-3004 as it relates to the requirement for 180 days of instructional time. According to your request, you are seeking to waive two (2) of the required 180 days of classroom instruction for Jefferson County Schools. You requested this waiver due to closures on August 8, 2023 as a result of a tornado that occurred on August 7, 2023. You are also requesting to waive November 29, 2023 as a result of widespread power outages throughout the county.

Pursuant to the commissioner's authority under Tenn. Code Ann. § 49-6-3004(a)(6)(A) to waive instructional days in the event a district experiences a natural disaster, your request is hereby granted.
