Dear Director Barker:

I am in receipt of your waiver request of State Board of Education Rule 0520-01-19-.03 as it relates to providing services and instruction to students in English as a Second Language Programs.

According to your request, you are seeking a waiver of this rule to better accommodate students in the district who attend the Nightly Alternative Program (NAP). This waiver would allow the school district to provide the required five (5) hours of daily ESL instruction within the four (4) days that students attend NAP.

Tenn. Code Ann. § 49-1-201(d) grants the commissioner the authority to "waive any state board rule or statute that inhibits or hinders the LEA's ability to meet its goals or comply with its mission." On the condition that Lenoir City Schools continue to provide monitoring as required under the State Board of Education Rule pertaining to English as a Second Language programs to ensure these ESL students' language needs are being met, your request is hereby granted for the remainder of the 2023-24 school year.

Please submit completed forms to <u>Commissioner.Education@tn.gov</u>. Following review by the commissioner, the LEA will be notified in writing if the waiver request is approved or denied. Unless otherwise stated, all waivers granted by the commissioner shall be granted for one-year terms.

Waivers may **not** be granted by the commissioner for regulatory or statutory requirements related to:

- (A) Federal and state civil rights;
- (B) Federal, state and local health and safety;
- (C) Federal and state public records;
- (D) Immunizations;
- (E) Possession of weapons on school grounds;
- (F) Background checks and fingerprinting of personnel;
- (G) Federal and state special education services;
- (H) Student due process;
- (I) Parental rights;
- (J) Federal and state student assessment and accountability;
- (K) Open meetings;
- (L) Educators' due process rights;
- (M) Reductions in teachers' salaries;
- (N) Employee rights, salaries and benefits; and
- (O) Licensure of employees.

### Explanation of how the statute(s) and/or state board rule(s) inhibits or hinders the local education agency's ability to meet its goals or comply with its mission:

Lenoir City Schools uses a Nightly Alternative Program to provide an educational setting for students that have been suspended from the standard school environment for disciplinary reasons. This program meets for four hours a day Monday - Thursday. We would like to request a waiver to provide the required ESL service time of 5 hours daily to providing 5 hours within the 4 days that students attend NAP.
