Dear Director Barker:

I am in receipt of your September 25, 2023 waiver request of State Board of Education Rule 0520-01-19-.03 requiring students identified for ESL services via a Tennessee Department of Education-approved English Language Proficiency screener to receive a minimum of one (1) hour each day of direct ESL services.

According to your request, you are seeking a waiver of this rule to better accommodate students at Lenoir City Elementary School and Lenoir City Intermediate Middle School who receive direct ESL services. You have indicated that a waiver of this rule will allow for greater flexibility to meet these students' individualized needs.

Tenn. Code Ann. § 49-1-201(d) grants the commissioner the authority to "waive any state board rule or statute that inhibits or hinders the LEA's ability to meet its goals or comply with its mission." On the condition that Lenoir City Schools continue to provide monitoring as required under the State Board of Education Rule pertaining to English as a Second Language programs to ensure these ESL students' language needs are being met, your request is hereby granted for the remainder of the 2023-24 school year.


