Re: Waiver for Average Class Size at Black Fox Elementary School

Dear Director Duke:

I am in receipt of your December 20, 2023 waiver request of the class size average found in Tenn. Code Ann. § 49-1-104 for 5<sup>th</sup> grade classes at Black Fox Elementary School in Murfreesboro City Schools.

The commissioner's waiver authority under Tenn. Code Ann. § 49-1-201(d) is limited by Tenn. Code Ann. § 49-1-104(a), which states that "neither the commissioner nor the state board of education shall grant waivers from the maximum class sizes established in this section."

With the understanding that none of the 5<sup>th</sup> grade classes at Black Fox Elementary School will exceed the maximum number of students per class specified in the above referenced law, your request for a waiver of the class size average is hereby granted for the remainder of the 2023-24 school year.

Dear Commissioner Reynolds,

I am writing to request a waiver regarding the average class size of Black Fox Elementary School in Murfreesboro City Schools. According to State Board of Education policy, the average class size in  $4^{th}-6^{th}$  grades should not exceed the 1 to 25 ratio with a maximum of 30 students per class.

Murfreesboro City Schools is requesting an increase in the class size average from 25 to 30 with no one class exceeding 30 students in 5<sup>th</sup> grade for the remainder of the 2023-2024 school year. A recent increase in students has this grade level currently at capacity. Any new enrollments when the school year resumes in January will put these classes above the maximum allowed.

After speaking with the school principal, district instructional team, and classroom teachers, it is our belief that students would best be served by remaining in their current classrooms for the remainder of the year. By adding another teacher, we will be disrupting the continuity of their 5<sup>th</sup> grade experience by moving them to a new classroom and a new teacher. Additionally, we have hired additional paraprofessional support specifically for this grade level to ensure student needs are met.

Our request is only for the remainder of this school year, and our staffing models for next year will allow us to return to the class size ratios found in State Board of Education policy.

Following review by the commissioner, the LEA will be notified in writing if the waiver request is approved or denied. Unless otherwise stated, all waivers granted by the commissioner shall be granted for one-year terms.

Waivers may **not** be granted by the commissioner for regulatory or statutory requirements related to:

- (A) Federal and state civil rights;
- (B) Federal, state and local health and safety;
- (C) Federal and state public records;
- (D) Immunizations;
- (E) Possession of weapons on school grounds;
- (F) Background checks and fingerprinting of personnel;
- (G) Federal and state special education services;
- (H) Student due process;
- (I) Parental rights;
- (I) Federal and state student assessment and accountability;
- (K) Open meetings;
- (L) Educators' due process rights;
- (M) Reductions in teachers' salaries;
- (N) Employee rights, salaries and benefits; and
- (O) Licensure of employees.
