Local Education Agency Waiver Request

Pursuant to Tennessee Code Annotated § 49-1-201(d), upon application by the local education agency for one (1) or more of its schools, the commissioner of education may waive any state board rule or statute that inhibits or hinders the LEA's ability to meet its goals or comply with its mission. Please submit completed forms to Commissioner.Schwinn@tn.gov. Following review by the commissioner, the district will be notified in writing if the waiver request is approved or denied. Unless otherwise stated, all waivers granted by the commissioner shall be granted for one year terms.

Waivers may **not** be granted by the commissioner for regulatory or statutory requirements related to:

- (A) Federal and state civil rights;
- (B) Federal, state and local health and safety;
- (C) Federal and state public records;
- (D) Immunizations;
- (E) Possession of weapons on school grounds;
- (F) Background checks and fingerprinting of personnel;
- (G) Federal and state special education services;
- (H) Student due process;
- (I) Parental rights;
- (J) Federal and state student assessment and accountability;
- (K) Open meetings;
- (L) Educators' due process rights;
- (M) Reductions in teachers' salaries;
- (N) Employee rights, salaries and benefits; and
- (O) Licensure of employees.

SBOE Rule 0520-01-02-.07(2) Library Information Center Personnel - Requires schools to employ a certain number of licensed library information specialists based on grade span and enrollment.

Explanation of how the statute(s) and/or state board rule(s) inhibits or hinders the local education agency's ability to meet its goals or comply with its mission:

The role of the library and the library personnel have changed to require supporting the literacy and technology needs of students and teachers, beyond the necessary library endorsements. We are requesting flexibility to seek out a licensed educator to mange our library that has a background in teaching literacy, as well as a demonstrated strength in technology utilization in student learning. We expect to then support the educator in obtaining the necessary endorsement as a library information specialist. This flexibility would allow us to meet both needs through prioritizing candidate's ability to support these identified areas and work towards endorsement.

Expected duration of the condition necessitating this waiver request:

We anticipate hiring a candidate for the 2023-2024 school year that fits the above description, and will work with this licensed educator to develop a timeline for obtaining the necessary library information specialist endorsement. Based upon expected course/degree requirements, this is likely to take 18-24 months, requiring this waiver for up to two school years.
