Re: Waiver for English as a Second Language (ESL) Programs

Dear Director Sullivan

I am in receipt of your August 14, 2023 waiver request of State Board of Education Rule 0520-01-19 requiring English as a Second Language (ESL) students to receive a minimum of one (1) hour each day from a teacher who holds an ESL endorsement.

According to your request, Rutherford County High School provides extended block class periods that meet every other day. Due to the way scheduling is structured, ESL students are unable to receive at least forty-five (45) minutes of ESL instruction each day. You have, therefore, requested that ESL students receive ninety (90) minutes of ESL instruction every other day to accommodate the school's block scheduling.

Tenn. Code Ann. § 49-1-201(d) grants the commissioner the authority to "waive any state board rule or statute that inhibits or hinders the LEA's ability to meet its goals or comply with its mission." On the condition that no ESL student at Rutherford County High School receive fewer than ninety (90) minutes of ESL instruction, your request is hereby granted for the 2023-24 school year.

RULES OF THE STATE BOARD OF EDUCATION CHAPTER 0520-01-19 ENGLISH AS A SECOND LANGUAGE PROGRAMS; RULE 0520-01-19-03-7-b

Explanation of how the statute(s) and/or state board rule(s) inhibits or hinders the local education agency's ability to meet its goals or comply with its mission:

The RCS high school schedule provides extended block class periods that meet every other day. Due to this, ESL students will not receive "full class periods of at least 45 minutes in duration **per school day.**" This schedule inhibits students from receiving services every school day even though they are scheduled to receive ESL services for one full class period.

The ESL service period will now be 90 minutes every other day instead of 45 minutes daily. 45 minutes of service over 10 school days is 450 minutes. A 90 minute block period meeting every other day over two weeks is also 450 minutes. Over a two-week period, the ESL students will receive the same amount service time that they would meeting daily.
