


State Performance Plan (SPP)

Under the Individuals with Disabilities Education Act (IDEA) of 2004, each state is required to annually develop a performance plan evaluating the state's implementation of special education.

- The SPP describes how the state will improve implementation of special education.
- The SPP contains rigorous targets for 17 compliancebased and results-based indicators of performance.
- Targets for these indicators are collaboratively set by the department and stakeholder groups.



Annual Performance Report (APR)



- The APR includes state data and explanations of data, if necessary.
- The federal fiscal year (FFY) 2020 APR (reporting on the 2020-21 school year), will be submitted on February 1, 2022.


Indicator 14: Post-School Outcomes

- Percent of youth who are no longer in secondary school, had IEPs in effect at the time they left school, and were:
 - A. Enrolled in higher education within one year of leaving high school;
 - B. Enrolled in higher education or competitively employed within one year of leaving high school; or
 - C. Enrolled in higher education or some other postsecondary education or training program, or competitively employed or in some other employment within one year of leaving high school.
- Data Source: Student survey administered by the Tennessee Department of Education (TDOE) and East Tennessee State University (ETSU).



Overall Five-Year Trends




The proposal for Indicator 14A is an **annual average increase of +1.17%***, starting with 2019-20 data:

Baseline (2009-10)	2019-20	2020-21	2021-22	2022-23	2023-24	2024-25	2025-26
22.00%	25.75%	26.92%	28.09%	29.26%	30.43%	31.60%	32.77%

Proposed Targets: Indicator 14B




The proposal for Indicator 14B is an **annual average increase of +1.13%***, starting with 2019-20 data:

Baseline (2009-10)	2019-20	2020-21	2021-22	2022-23	2023-24	2024-25	2025-26
57.00%	62.55%	63.68%	64.81%	65.94%	67.07%	68.20%	69.33%

Proposed Targets: Indicator 14C




The proposal for Indicator 14A is an **annual average increase of +0.53%***, starting with 2019-20 data:
