Dr. Bill Campbell, Chairman

Dr. Jason Robinson asked for clarification of the bidding process from TDOE staff attorney, Joanna Collins. Ms. Collins explained the guidance that the TDOE staff has provided to publishers and offered to present formalizing this guidance at the next meeting. Dr. Tammy Shelton said the first and final reading of the policy will take place at the March, 2017 meeting.

Mr. Kyle Mallory stated that there are still issues with seventh grade Social Studies and said there hasn't been enough statewide training in the area. He further stated that his offer to assist the department still stands, as his willingness to volunteer the past two years. Mr. Mallory commended the department on both the Science and Social Studies standards process. Dr. Tammy Shelton explained that the cycle takes 21 months. The standards must be completed first and these are currently under revision and are with the State Board of Education. She referred members to the TDOE webpage for review of the standards. Chairman Campbell reminded the commission that textbook materials are housed at MTSU, open to everyone, and he encouraged the members to block out some time to look through the materials.
