Re: DOE Federal Facility Agreement (FFA) Milestone Extension Request for the Environmental Management Disposal Facility (EMDF) Record of Decision (ROD) and Follow-on Documents

Dear Mr. Japp

The Tennessee Department of Environment and Conservation (TDEC) received the referenced milestone extension request for the proposed Environmental Management Disposal Facility (EMDF) Record of Decision (ROD) and follow-on documents on September 3, 2019. The U.S. Department of Energy (DOE) letter requests extension of the ROD milestone from August 30, 2019 to September 30, 2019. If the ROD selects onsite disposal, additional submittal dates include July 2, 2020 for the EMDF RDWP and June 8, 2021 for the EMDF Remedial Design Report/Remedial Action Work Plan (RDR/RAWP).

In accordance with the Federal Facility Agreement (FFA) for the Oak Ridge Reservation, TDEC approves DOE's milestone extension request. DOE's request provides the following basis for the extension:

"The reason for this extension is given under Federal Facility Agreement Subsection XXX.B.5 (delay caused by additional work agreed to by the Parties). The reason for the delay is to allow the discussion among the U.S. Environmental Protection Agency Administrator, representatives from DOE, and the Tennessee Department of Environment and Conservation on the Focused Feasibility Study for Water Management for the Disposal of CERCLA Waste on the Oak Ridge Reservation, Oak Ridge, Tennessee (DOE/OR/01-2664&D2) dispute concerning the regulation of wastewater effluents containing source, special nuclear and byproduct materials scheduled for September 6, to inform the draft ROD."

DOE's request also states, "Previous ROD extension request approval letters from the Tennessee Department of Environment and Conservation have reiterated requests to incorporate the key concerns of the state in the draft document. The D1 ROD submittal will address those concerns." As a point of clarification, TDEC's previous letters say that the ROD must resolve the State's key concerns. Therefore, TDEC will continue working in good faith with DOE and EPA to develop a final ROD that achieves this CERCLA requirement, in addition to CERCLA threshold criteria—overall protection of human health and the environment and compliance with (or justified waivers for) ARARs¹.

As the State of Tennessee continues to work with DOE and EPA to seek innovative solutions to the challenges of CERCLA waste disposal, TDEC appreciates DOE's statements of willingness to allow the time needed for review and approval of all necessary aspects of the ROD. In the spirit of partnership and cooperation, TDEC reiterates its August 12, 2019, request for DOE to provide a schedule for resolving the State's key concerns. The schedule needs to align with FFA review periods for the D1 and D2 ROD, and it should include an additional public comment opportunity after DOE updates community members on new information developed after DOE issued the Proposed Plan.

This purpose of this letter is to respond to the Department of Energy's (DOE) August 29, 2019, request for an extension, under Section XXX of the Oak Ridge Reservation Federal Facility Agreement (FFA), of the D1 Record of Decision (ROD) for the Environmental Management Disposal Facility.

DOE provided as its basis for an extension

... under Federal Facility Agreement Subsection XXX.B.5 (delay caused by additional work agreed to by the Parties). The reason for the delay is to allow the discussion among the U.S. Environmental Protection Agency Administrator, representatives from DOE, and the Tennessee Department of Environment and Conservation on the Focused Feasibility Study for Water Management for the Disposal of CERCLA Waste on the Oak Ridge Reservation, Oak Ridge, Tennessee (DOE/OR/01-2664&D2) dispute concerning the regulation of wastewater effluents containing source, special nuclear and byproduct materials scheduled for September 6, to inform the draft ROD.

While the DOE extension request references the dispute concerning wastewater effluents containing source, special nuclear and byproduct materials (Atomic Energy Act (AEA) materials), the EPA dispute addresses all waste waters, including those containing AEA materials, generated from Comprehensive Response, Compensation, and Liability Act (CERCLA) activities and discharged to surface waters.

Because it is not clear that "additional work" is being conducted as described in FFA Section XX, and consistent with EPA's July 31, 2019, response to DOE's July 30, 2019, extension request, the EPA agrees that DOE has established good cause under FFA Section XXX.B.3 (a delay caused by the good faith invocation of dispute resolution) for the extension request. The EPA will continue to work with the DOE to maintain open communication concerning project status, issues, and schedules as we progress toward determining the site suitability and protectiveness of the EMDF at Site 7c in Central Bear Creek Valley.

The EPA is approving the request as submitted with the new milestones to be reflected as follows:

D1 ROD: September 30, 2019

RDWP: July 2, 2020

RDR/RAWP: June 8, 2021

Due to the cost of the EMDF project as proposed, the EPA Administrator will select the remedy, and Region 4 will brief the EPA Administrator prior to remedy selection. Finally, EPA notes that, the formal dispute regarding the EMWMF-EMDF Wastewater Focused Feasibility Study should be resolved and its results incorporated into DOE's submission of the D1 ROD, consistent with FFA Section XXVI.J.

FEDERAL FACILITY AGREEMENT MILESTONE EXTENSION REQUEST FOR ENVIRONMENTAL MANAGEMENT DISPOSAL FACILITY RECORD OF DECISION AND FOLLOW-ON DOCUMENTS

In accordance with the Federal Facility Agreement for the Oak Ridge Reservation, the U.S. Department of Energy (DOE) requests your approval to modify the Appendix E milestone dates for submission of the Record of Decision (ROD), the Remedial Design Work Plan (RDWP), and the Remedial Design Report/Remedial Action Work Plan (RDR/RAWP) for the Environmental Management Disposal Facility. This extension requests moving the milestones out four weeks for the ROD and eight weeks for the RDWP and RDR/RAWP.

Schedule and dates sought to be extended: The current milestones are as follows:

ROD: August 30, 2019 RDWP: May 5, 2020 RDR/RAWP: April 9, 2021

Length of extension sought: About four weeks (22 working days) for the ROD and 43 working days for the RDWP and RDR/RAWP.

New milestone dates: The requested new milestone dates are as follows:

ROD: September 30, 2019 RDWP: July 2, 2020 RDR/RAWP: June 8, 2021

Good cause for extension: The reason for this extension is given under Federal Facility Agreement Subsection XXX.B.5 (delay caused by additional work agreed to by the Parties).
