TDEC Comments

Federal Facility Agreement Milestone Extension Request for Environmental Management Disposal Facility Record of Decision and Follow-on Documents

The Tennessee Department of Environment and Conservation (TDEC) Division of Remediation has reviewed the extension request cited above (B. Henry and J. Japp to C. Jones and R. Young dated January 16, 2018 and received on January 18, 2018) pursuant to Section XXX.D of the Federal Facilities Agreement. Based on the review, the State approves the requested extension of the milestones for submission of the Record of Decision (ROD) and follow-on documents for the Environmental Management Disposal Facility.

The change is to allow time to develop and reach approval of the Proposed Plan and conduct public review of the approved Proposed Plan. In accordance with the December 7, 2017 *Dispute Resolution Agreement*, a TDEC/EPA-approved Field Sampling Plan (FSP) will be appended to the Proposed Plan. The results and analysis of the field investigation in accordance with the FSP shall be included in the administrative record before the Proposed Plan public comment period. TDEC and EPA review of the field investigation results shall be completed before execution of the ROD and shall be used in selecting the remedy.

Scheduled milestones: The scheduled milestones were as follows:

ROD: March 16, 2018 RDWP: December 18, 2018 RDR/RAWP: November 22, 2019.

• Length of extension: The new milestones with the requested extensions are as follows:

ROD: September 17, 2018 RDWP: June 18, 2019 RDR/RAWP: May 22, 2020.

- Reason for extension: The extension (FFA Subsection XXX.B.3 good cause) is needed due
 to delays caused by DOE's good-faith invocation of dispute resolution. The U.S.
 Department of Energy proposes the extension to allow time to develop and reach
 approval of the Proposed Plan and conduct public review of the approved Proposed
 Plan, including the site characterization, analysis, and reporting described above.
- Related schedules impacted by extension: The extension of these milestones should not impact any other schedules or milestones.
- Implementation strategy: The implementation strategy is to continue with scheduled meetings, work to complete characterization, and continue to provide open communication of project status, issues, and schedules with the Project Team.

The *Dispute Resolution Agreement* also provides for TDEC's independent verification of DOE modeling to determine waste acceptance criteria that protect human health and the environment. DOE's project schedule should reflect the need for this FFA oversight activity that directly supports the ROD. TDEC's ability to complete the independent verification depends on DOE providing, in a timely manner, all materials necessary to complete this review.

The Environmental Protection Agency has received the Department of Energy (DOE) letter requesting an extension for the submittal of the Environmental Management Disposal Facility Record of Decision (ROD) and follow-on documents. The request was submitted from DOE on January 16, 2018, and received by EPA on January 25, 2018.

The requested six-month extension is to provide sufficient time to develop and reach approval of the Proposed Plan, conduct a limited field characterization effort at the Central Bear Creek Valley Site 7c locale, issue the Proposed Plan, and conduct a public meeting. This extension will also include subsequent Comprehensive Environmental Response, Compensation, and Liability Act, Federal Facility Agreement documents including the Remedial Design Work Plan and the Remedial Design Report/Remedial Action Work Plan.

In accordance with FFA Subsection XXX:.8.6, the DOE has established good cause for the extension request. The EPA is approving the request as submitted and will continue to work with DOE to maintain open communication concerning project status, issues, and schedules as we progress toward finalizing this comprehensive monitoring plan.

FEDERAL FACILITY AGREEMENT MILESTONE EXTENSION REQUEST FOR ENVIRONMENTAL MANAGEMENT DISPOSAL FACILITY RECORD OF DECISION AND FOLLOW-ON DOCUMENTS

In accordance with the Federal Facility Agreement (FFA) for the Oak Ridge Reservation, the U.S. Department of Energy requests your approval to modify the Appendix E milestone dates for submission of the Record of Decision (ROD), the Remedial Design Work Plan (RDWP), and the Remedial Design Report/Remedial Action Work Plan (RDR/RAWP) for the Environmental Management Disposal Facility. This extension request moves the milestones out six months; however, every attempt will be made to submit the ROD (and subsequent documents) as soon as possible prior to the stated extended dates, since per the signed formal dispute agreement all parties have agreed to give their best efforts to issue a Proposed Plan in a time frame that could allow a more expedient ROD submittal date.

Schedule and dates sought to be extended: The current milestones are as follows:

ROD: March 16, 2018

RDWP: December 18, 2018

RDR/RAWP: November 22, 2019

FEDERAL FACILITY AGREEMENT MILESTONE EXTENSION REQUEST FOR ENVIRONMENTAL MANAGEMENT DISPOSAL FACILITY RECORD OF DECISION AND FOLLOW-ON DOCUMENTS

Length of extension sought: Six months for each milestone.

New milestone dates: The requested new milestone dates are as follows:

ROD: September 17, 2018 RDWP: June 18, 2019

RDR/RAWP: May 22, 2020

Good cause for extension: The reason for this extension is under FFA Subsection XXX.B.3 (good cause) due to delays caused by the good faith invocation of dispute resolution. The U.S. Department of Energy is proposing the above dates to allow enough time to develop and reach approval of the Proposed Plan, conduct the public review of the approved proposed plan, and conduct associated, limited characterization as defined in the formal dispute agreements.
