- Terms of CRF grant gives state until September of 2021 to resolve for <u>expenses</u> <u>incurred</u> in 2020. State plans to complete accounting prior to June 30
- December actions:
  - 1. Account for any realized savings/underutilization in programs;
  - 2. Begin closure of existing programs;
  - 3. Monitor additional federal action

## Potential Underutilized Funds & Savings

- As of 11/18, \$13 million in relief funding turned down by hospitals. Flexibility exists to re-allocate within program for hospitals with requests in excess of allocation.
- Community CARES has less than 10% in reported and likely underutilized funds. Additional reporting from grant administrators pending.
- Savings potential with request outstanding to FEMA for cost-share of \$71 million expended towards school and public re-opening costs. Previously disallowed under new FEMA policy. At 75% federal cost-share, this creates potential for \$53 million in newly available funds.
