How to pay your CLIA fee online with a credit card

To pay your CLIA fee with a credit card use the following link: https://www.pay.gov/paygov/.



There is a lot of information available to you when you logon. You have the option of registering with the site or just paying your fee without registering. To begin, type the word **CLIA** in the search box and click **Search**:

If you enter the address or the name of the laboratory differently than how it is listed in the CLIA Data system it is okay. There are no edits against the CLIA database by Pay.gov.

Pay.gov caveats:

- 1. Payments to more than one CLIA number at a time are not allowed.
- 2. There is no place for a comment or note.
- 3. Attachment of any documentation (such as the fee coupon or a request for address change) is not possible.
- 4. P aying one fee with two credit cards at the same time is not possible. However, multiple single transactions for the same fee is allowed. Each transaction has to be performed separately.
