Upon the determination of a quorum being present, the Board meeting was called to order by Dr. Halford at 1:05 p.m.

Approval of Minutes

Dr. Galloway made a motion, seconded by Ms. Walsh to approve the July 29, 2014 and August 26 - 27, 2014 minutes. The motion carried.

Applicant Interviews

Jacob E. Baum, C.A.E.T.

The Board reviewed an application for certification as an animal euthanasia technician submitted by **Jacob E. Baum**. Mr. Baum answered "yes" to the question on the application regarding conviction of a felony or misdemeanor other than a minor traffic offense. Mr. Baum was present

to answer any questions from members of the Board regarding a 2008 Reckless Driving conviction. Mr. Baum submitted a letter or recommendation from his supervisor. After discussion and review of the documentation, Ms. Walsh made a motion, seconded by Dr. Johnson, to approve the application. The motion carried.

File Review

John D. Coulter, Jr., D.V.M.

The Board reviewed an application for reinstatement of an expired license to practice veterinary medicine submitted by **John Coulter, Jr., DVM.** Dr. Coulter's Tennessee License No. 2800 expired on 01/01/1991. Dr. Coulter has continuously worked in a veterinarian position since 1986 in other states and during his military service from 2001 – present. Dr. Coulter was required to retain an active veterinary license and complete continuing education hours during his military service. Dr. Coulter requested a reduction of fees and a waiver of continuing education hours. Upon discussion, Dr. Galloway made a motion, seconded by Dr. Reynolds to accept the continuing education hours presented and waive the remaining hours. The motion carried. Dr. Federico made a motion to reduce the fees to \$135.00 (the fee payment due for reinstatement of a retired license) due to Dr. Coulter's military service. Dr. Galloway seconded the motion. The motion carried.

Conflict of Interest Statement

Mr. Keith Hodges, Board Attorney, reviewed the Conflict of Interest Policy.

Office of General Counsel (OGC) Report

Mr. Keith Hodges, Board Attorney, reported the Office of General Counsel has sixteen (16) open cases pertaining to the Board of Veterinary Medical Examiners. There are five (5) Consent Orders and one (1) Order of Compliance to be presented to the Board at this meeting.

Progress Report – Stacy R. Smith, D.V.M.

As per the Consent Order approved by the Board on April 10, 2014, Dr. Smith appeared before the board for his annual appearance.

Order of Compliance – Elisha M. Argo, LVT

Mr. Keith Hodges, Board Attorney, presented the Order of Compliance to the Board. Ms. Argo was present to answer any questions. Dr. Galloway made a motion, seconded by Dr. Reynolds, to approve the Order of Compliance. The motion carried.

Consent Order – Prudence B. Walker, D.V.M.

Dr. Prudence Walker was not present and was not represented by counsel. Mr. Keith Hodges, Assistant General Counsel, presented the Consent Order to the Board for ratification. Dr. Prudence posted an advertisement on Craigslist in which she offered to provide a range of veterinary services from her home. She does not hold a premise permit for her home. Dr. Walker agreed to pay a civil penalty in the amount of \$500.00. Ms. Walsh made a motion, seconded by Dr. Johnson, to accept the Consent Order. The motion carried.

Consent Order – Amy Keller, L.V.T.

Ms. Keller was not present and was not represented by counsel. Mr. Keith Hodges, Assistant General Counsel, presented the Consent Order to the Board for ratification. Ms. Keller stole Trifexis worth over fifteen thousand dollars (\$15,000.00) from her employer. She pled guilty to Theft of Property worth between \$10,000 and \$60,000, a Class C felony, in Shelby County Criminal Court. Ms. Keller agreed to voluntarily surrender her license to practice as a veterinary technician and to pay costs of the proceedings. Dr. Galloway made a motion, seconded by Dr. Federico, to accept the Consent Order. The motion carried.

Consent Order - Mary E. Stanley, D.V.M.

Dr. Stanley was not present and was not represented by counsel. Mr. Keith Hodges, Assistant General Counsel, presented the Consent Order to the Board for ratification. Dr. Federico recused himself. Dr. Walker operated and practiced in a veterinary facility with an expired premise permit from February, 2013 – October, 2014. Dr. Walker agreed to pay total civil penalties in the amount of three hundred and fifty dollars (\$350.00) plus costs of the proceedings. Ms. Walsh made a motion, seconded by Dr. Johnson, to accept the Consent Order. The motion carried.

Financial Report

Ms. Lisa Tittle, Fiscal Services, reviewed the financial report for the fiscal year ending June 30, 2014. Ms. Tittle provided an explanation of expenditure line items. The report reflected a current year net of \$45,866.74 and a \$341,159.95 cumulative carryover as of June 30, 2014.

Investigations and Disciplinary Report

Ms. Nichelle Dorroh, Disciplinary Coordinator, reported there are currently thirty-eight (38) open complaints in the Office of Investigations.

Chronic Pain Guidelines

At the July 29, 2014 board meeting, Dr. Andrew Holt, Director, Controlled Substance Monitoring Database, gave a presentation on the chronic pain guidelines finalized in May 2014. The purpose of these guidelines is to define appropriate treatment of chronic pain. These

guidelines are intended to be used to support clinicians in their treatment of patients with chronic pain with particular reference to the prescribing of opioid medications in hopes of avoiding addiction and adverse outcomes. While the guidelines have marginal applicability to veterinary medicine, the Veterinary Board does have representation on the committee. The Board expressed their support of these guidelines.

Discussion – 2015 Music City Veterinary Conference

The 2015 Music City Veterinary Conference is scheduled to be held February 27 – March 1, 2015 at the Embassy Suites Hotel in Murfreesboro, TN. Dr. Galloway made a motion, seconded by Ms. Walsh, to fund the cost for Ms. Lampley to attend and be an exhibitor at the conference. The motion carried.

Position Statement – Release of Prescriptions

Upon discussion, Dr. Galloway made a motion, seconded by Dr. Johnson, to adopt the following position regarding the release of prescriptions upon client requests:

- 1. Drug therapy, when medically indicated, should be initiated by the attending veterinarian in the context of veterinarian-client-patient relationship. Clients that wish to purchase their prescription drugs from a pharmacy rather than the veterinarian should be advised to first obtain a prescription from their veterinarian before contacting a pharmacy. The veterinarian may choose to either issue the prescription in writing for the client, or contact the pharmacy electronically or by phone.
- 2. Veterinarians shall honor client requests to prescribe rather than dispense a drug (AVMA Principles of Veterinary Medical Ethics). The client has the option of filling a prescription at any pharmacy.
- 3. One factor in evaluating the quality of an Internet pharmacy is accreditation by a recognized organization such as the National Association of Boards of Pharmacy (NABP). The NABP has developed the Vet-VIPPS program designed to ensure that Internet pharmacies that sell veterinary drugs are properly licensed and meet other program requirements. Further information is available at www.nabp.net.
- 4. Veterinarians asked by pharmacies to approve prescriptions they have not initiated should do so only if the prescription is appropriate and a veterinarian-client-patient relationship exists.
- 5. It is within the veterinarian's (not the pharmacy's) purview to determine the medical criteria whereby a drug is indicated.
- 6. As with any prescription, a written record should be maintained.
- 7. Prescribing veterinarians should ensure that information regarding the proper use and dosage of the prescribed drug and the risks associated with its use are communicated to the client, regardless of the drug source.

- 8. If a client asks about obtaining drugs from a foreign country through an Internet source they should be aware that the importation and use of drugs not approved by the FDA is illegal.
- 9. It is not unethical for a veterinarian to charge a reasonable professional fee for a prescription.

The motion carried.

Report – Controlled Substance Monitoring Database

Dr. Kim Johnson gave a brief update on the committee's work and stated that no veterinarian has been identified as one of the top prescribers. The next committee meeting is scheduled for January 26, 2015.

Legislative Update

Board members were reminded that the following bill which prohibits the licensure renewal of licensees with privilege tax delinquencies is now being implemented:

<u>Public Chapter 763</u> — This act revises delinquent privilege tax provisions that would require the Department of Revenue to notify the licensee that failure to cure the delinquency or deficiency prior to their licensure renewal date can result in renewal abeyance. For purposes of the bill, "cure" means payment in full, entering into an agreed payment plan, or abatement of tax liability. Licensing boards will be provided monthly with list of licensees who are delinquent 90 days or more and boards may not process licensure renewal.

Inspection Status Report

A total of one hundred sixty (160) inspections were conducted during the period of July – October, 2014.

Director's Report

Ms. Lampley expressed her appreciation to Dr. Forrest Reynolds, Board Vice-President, for his hard work and contributions to the Board and his willingness to continue to serve until a replacement member is appointed. Dr. Reynolds' term expired on July 31, 2014.

Dr. Galloway and Ms. Lampley attended the American Association of Veterinary State Boards (AAVSB) Annual Meeting and Conference held September 11 - 13, 2014 in St. Petersburg, Florida. A recap of the conference is available on the AAVSB website. Next year's meeting will be held September 17 - 19, 2015 in Milwaukee, WI.

Students from the UT College of Veterinary Medicine will be attending the upcoming Music City Veterinary Conference. Ms. Lampley will be speaking to the students on Friday, February 27th and invited members of the board to join her in the presentation.

The Board reviewed correspondence from **Thomas D. Edmonds, D.V.M.**, regarding his concerns with "Rabies Clinics" protocols and regulations. Dr. Edmonds asked if rabies vaccination clinic sponsors are held to the same standards (i.e. valid veterinary client patient relationship, provisions for emergency care, recordkeeping requirements) as all the veterinary practices in Tennessee.

Rule 1730-02-.01(16) defines "Public Rabies Vaccination Clinic" as "a clinic sponsored by a local health department to provide vaccination of dogs and cats against rabies, under the local health department's ordinances and regulations."

Public rabies vaccination clinics as defined above would not be held to the same standard as a vaccination clinic held in a veterinary facility with a premise permit.
