Mr. Ward then went on to explain that have started working on recommendations for the services to make sure they have to people to work on the vehicles. The first one is the getting the conditional licenses issued and if they run through them and still need people they will look into having the ones that hold an EMT license but may not be working in the field now and may be working for a Fire Department to come over and work if possible. If we go through all of them, looking at EMR and possible looking at EMT students that have completed the didactic portion and place them in the service. They may not hold a license, but they have had the training. Once all of those resources have been exhausted, they will be looking at anyone who have the necessary driver's license and even looking at the military medic, even just military personal. Military personal is trained in operating heavy equipment vehicles and taking orders. Mr. Ward stated that they will not wave the rule about bringing in people that are not licensed as an EMT in to drive the vehicles at this time. He stated that if we ever reach that level, we need to make sure we put people that have been trained or at least has a CDL license. Mr. Ward stated that they have come up with alternative staffing plans that they have talked to the Regional Consultants but have asked them not to discuss this publicly.

Mr. Ward talked about the Regional Consultants that EMT, AEMT and Paramedics are not to be used to help test for the COVID. The rule states that they can vaccinate but they cannot test.

Dr. Holley asked if the Committee Meetings have been canceled and Mr. Ward stated that all meeting in the building have been postponed until further notice. Dr. Smith asked if anybody else had anything to discuss and Mr. Ward stated that it will require a roll call vote to adjourn.
