#### Call to Order

Ms. Wereszczak made a motion to approve the Board meeting Minutes from December 14, 2022, with a second by Dr. Garrett. There was a brief discussion to review the chart of proposed fee changes report in the minutes, as discussed in the previous meeting. No changes were made.

The motion passed unanimously.

Discussion on the report is as follows: Dr. Garret inquired about letters of warning and concern, and who originates them. Mr. Peters, General Counsel, confirmed they are sent out by the Office of General Counsel. Dr. Garret followed up and inquired what happens if the recipient of a letter

doesn't understand or doesn't agree with a letter, what is their recourse in extending communication with the State on the content of the letter. Mr. Peters stated the OGC cannot provide legal advice to the recipient, they would need to follow-up with their own legal counsel for guidance, and further communication with the OGC may result, should the licensee reach out to the OGC for follow-up; It is handled on a case-by-case scenario. Mr. Peters went on to say that a Declaratory Order can be issued in certain circumstances, on an individual basis, and would require additional steps to be taken to determine if that would be an appropriate consideration. First steps would be the licensee or their representation reaching out to the OGC. Board Members cannot get involved in any issue experienced by a licensee on an individual basis.

Dr. McInturff asked if a licensee is notified of the findings of a review. Mr. Peters noted that investigations are confidential, and if there is no violation or merit for moving forward, that is the end of the process for the OGC. The Office of Investigations has their own process for closing out cases. Dr. McInturff stated that it feels like many instances are due to miscommunication and would like to see a public notification if an investigation is closed with no action. Dr. Galloway noted that investigations are held within the Office of Investigations and OGC, not directly through the Board. Mr. Peters stated that he will review the policies for handling no action items by the Office of Investigations. Ms. Granum also noted that a licensee who has been interviewed should receive a disposition letter at the end of the investigation, and they are always welcome to contact the Disciplinary Coordinator for follow-up as well.

# Presentation of Orders, Agreed Citations, and Other Disciplinary Items

## **Consent Orders**

#### Anthony Ashey, DVM #4296

Respondent has been at all times pertinent hereto licensed by the Board as a veterinarian in the state of Tennessee, having been granted license number 4296 on May 16, 2003, with a current expiration date of April 20, 2024.

At all times pertinent hereto Respondent was working as a veterinarian in Chattanooga, TN.

On or about April 17, 2019, W.D. transported his dog Nikki, to an animal clinic in Chattanooga, Tennessee, where the Respondent performed a caesarean section on Nikki. Following the surgery, according to W.D., Nikki was bleeding excessively on the way home. W.D. phoned Respondent to voice his concern and was told by Respondent, "a lot of blood to him was not the same as a lot of blood to a veterinarian". W.D. felt as if the Respondent was dismissing the owner's concerns. The Respondent offered to examine the dog.

The next day when Respondent phoned to check on Nikki, W.D. said she was still bleeding, panting heavily, and refused to feed her puppies. Respondent stated some dogs are not good mothers and had no explanation for the heavy panting. The Respondent offered to examine the dog.

As Nikki became increasingly worse over the weekend, she was taken to a different animal clinic on the following Monday, April 22, 2019. An ultrasound was performed by a different veterinarian which revealed that Nikki still had a puppy inside her womb. The new veterinarian performed another caesarean section to remove the dead puppy and Nikki was placed on heavy sedation. Respondent stated he had taken x-rays on April 16, 2019, but not an ultrasound, and it showed three (3) possibly four (4) puppies. Respondent delivered five (5) puppies, and stated he thought he had delivered all the puppies. The Respondent did not.

For the purpose of avoiding further administrative actions with respect to the cause, Respondent agrees to the following:

Respondent's license to practice as a veterinarian (license number 4296) is hereby Reprimanded. Respondent agrees to pay a Type B Civil Penalty in the amount of five hundred dollars (\$500).

Respondent must pay, pursuant to Tenn. Code Ann §63-1-144, the actual and reasonable costs of prosecuting this case to the extent allowed by law, including all costs assessed against the Board

by the State in connection with the prosecution of this matter. These costs will be established by an Assessment of Costs prepared and files by counsel for the State. The maximum amount for the assessment of costs shall be one thousand dollars (\$1,000).

Respondent understands the ratification of the Consent Order is a formal disciplinary action and will be reported to the National Practitioner Data Bank and/or similar agency, as a Reprimand and Civil Penalty. Respondent further understands that a failure to comply with the terms of this order shall constitute grounds for disciplinary action.

Dr. Garrett made a motion to accept the Consent order, with a second from Dr. McInturff. Discussion is as follows: Ms. Wereszczak asked if there was any requirement for CE included in the penalty listed in the Order, Mr. Peters confirmed there was not. The motion passed with an Aye from Dr. Garrett, Ms. Wereszczak, Dr. McInturff and a Nay from Dr. Galloway.

## Day and Night Animal Hospital, LLC #1856

Respondent has been at all times pertinent hereto licensed by the Board as a veterinary facility in the State of Tennessee, having been granted license/permit number 1856 on or about December 20, 2016, which expired on December 31, 2020

At all times pertinent hereto Respondent facility was located in Memphis, Tennessee.

On or about December 31, 2020, Respondent's premises permit expired. On May 11, 2022, the Respondent applied for a new license with a new business name, which was approved on September 20, 2022.

For the purposes of avoiding further administrative actions with respect to this cause, Respondent agrees to the following:

Respondent agrees to pay a Civil Penalty in the amount of one thousand dollars (\$1,000), which represents \$100 for each of the ten (10) months that the facility engaged in the practice of veterinary medicine, beyond the six (6) month grace period, on a n expired license/permit.

Respondent understands the ratification of the Consent Order is a formal disciplinary action and will be reported to the National Practitioner Data Bank and/or similar agency, as Civil Penalty. Respondent further understands that a failure to comply with the terms of this order shall constitute grounds for disciplinary action.

Dr. McInturff made a motion made to accept the Consent order, with a second from Dr. Garrett. Discussion is as follows: Dr. Garrett inquired about the disciplinary action is against the old or the new premises permit. Mr. Peters stated that the discipline is against the old permit, and it is issued in alignment with the Board's policy. The motion passed unanimously.

Jennifer Lucas, DVM #4009

Respondent has been at all times pertinent hereto licensed by the Board as a veterinarian in the State of Tennessee, having been granted license number 4009 on August 23, 2000, which currently has an expiration date of January 31, 2024

At all times pertinent hereto Respondent was working as a veterinarian in Mt. Juliet, Tennessee.

On or about July 19, 2022, an investigator for the Office of Investigations for the State of Tennessee ("Investigators") went to a pet hospital owned by Respondent. Investigators found out that Respondent had an invoice for 500 tablets of Tramadol from December 31, 2021. However, the dispensing log did not have the Tramadol documented. Respondent was unable to explain why the Tramadol was not recorded on the dispensing log and admitted to investigators that Respondent ordered the Tramadol. On or about September 9, 2022, through Respondent's attorneys she contacted Investigators and explained that she was not trying to deceive anyone concerning the Tramadol, and that Respondent bought the entire bottle of 500 pills of Tramadol to give to her grandmother. Respondent gave her grandmother the pills because she had run out of her prescription medication for Tramadol, while she was here in Tennessee for the holidays. On or about September 12, 2022, through Respondent's attorneys, she provided Investigators documentation which corroborated what had occurred.

For the purpose of avoiding further administrative actions with respect to this cause, Respondent agrees to the following:

Respondent's license to practice as a veterinarian (license number 4009) is hereby Reprimanded.

Respondent shall immediately placed on probation for two (2) years with the following terms and conditions:

- 1. The two year probation term shall commence on the date this Order is signed by the Board.
- 2. Respondent shall complete five (5) hours of continuing education in the areas of narcotics and controlled substances in each of the two (2) years she is on probation for a total of ten (10) hours. The continuing education in the areas of narcotics and controlled substances is in addition to the regular required continuing education for veterinarians to be completed each calendar year.
- 3. Respondent shall appear each year before the Board at the August board meeting to provide information and documentation showing compliance with the terms and conditions of probation.

Respondent agrees to pay a Civil Penalty in the amount of one thousand dollars (\$1,000).

Respondent understands the ratification of the Consent Order is a formal disciplinary action and will be reported to the National Practitioner Data Bank and/or similar agency, as a Reprimand with Probation. Respondent further understands that a failure to comply with the terms of this order shall constitute grounds for disciplinary action.

Dr. Garrett made a motion to accept the Consent Order, with a second by Dr. McInturff. Discussion is as follows: Dr. Galloway inquired if he could ask Dr. Baron (Tennessee Medical Foundation Medical Director) a question as to how this would be handled on the human side. Mr.

Peters stated that his opinion is that the Board should not ask for outside advisement in this situation and not be influenced by an outside party. Dr. Galloway did not ask his question of Dr. Baron

Ms. Wereszczak inquired if it was definitively determined that the licensee gave the pills to her grandmother. Mr. Peters informed the Board that a Consent Order being presented is what has gone back and forth between the OGC and the licensee and is presented as what has been singed/agreed upon the Respondent and the State.

Dr. Beaty inquired if this was a sufficient penalty, and should the licensee be required to have supervision going forward. Dr. Galloway is concerned that this is diversion of a controlled drug and probation is as far as the Order can go without revoking the license. Dr. Galloway noted the OGC is recommending probation, Mr. Peters stated that OGC is following the parameters that has been given to them and it is up to the Board on how they'd like to proceed.

The motion passed with an Aye from Dr. Garrett, Dr. Galloway, Dr. McInturff and a Nay from Ms. Wereszczak. The motion passed.

# Thomas Holt, DVM #4558

Respondent has been at all times pertinent hereto licensed by the Board as a veterinarian in the state of Tennessee, having been granted license number 4558 on June 20, 2005, with a current expiration date of November 30, 2024.

On or about May 7, 2021, Respondent diagnosed Ryder, a miniature schnauzer, with a rear hip dislocation and a fracture on his front leg. Surgery was performed that day.

Respondent did not immobilize Ryder's hip after surgery or clean the incision site. In addition, the rear leg was not in a sling or in any way immobilized. Respondent instructed Ryder's owner that Ryder was to return in four (4) weeks.

Ryder's owner called the Respondent's office expressing concerns due to the splint on Ryder's forepaw. Respondent's wife, who is not licensed as a veterinarian, offered pain meds to Ryder's owner to help alleviation Ryder's pain.

On or about May 19, 2021, another veterinarian made a home visit to vaccinate other dogs in the household. This veterinarian checked Ryder and was concerned regarding the splint on Ryder's front leg developing sores and advised Ryder's owner to clean the incision site. On or about May 20, 2021, Ryder's owner called to set up an appointment with the Respondent for a splint and dressing change the next day. When the owner and Ryder arrived, Respondent was not in the office. Respondent's wife took out the staples and stiches from the incision site. Under the splint on the front leg a pressure sore was festering with pus oozing from the pressure sore.

On or about May 25, 2021, Ryder was brought back to Respondent's office, and Respondent refused to change the splint, calling the pressure sores "par for the course". Respondent did not take x-rays of the front and back legs.

On or about May 27, 2021, Ryder's owner removed the splint off the foreleg, concerned about the

festering pressure sore. There was no padding under the splint., and adhesive tape was used in excess around the splint.

On or about May 31, 2021, Ryder's owner called Respondent's office to request a copy of his x-rays. There was no reply from the Respondent.

On June 4, 2021, Ryder's owner took him to see the veterinarian who saw Ryder on May 19, 2021. That veterinarian took x-rays and determined that the hip was not in the socket, and she could not see a fracture in the foreleg, however, it appears that the elbow joint had been out of socket. The recommendation was for Ryder to see a specialist, who would either perform surgery or an amputation. The splint was changed to a soft splint and the owner was instructed to change the bandages every week.

On or about June 18, 2021, Ryder went back to the second veterinarian, and x-rays were once again taken. There had been no fracture on the foreleg, but the elbow joint was, swollen and unable to bend due to the displacement. The veterinarian tried multiple times to obtain Ryder's medical records from the Respondent but was unable to do so.

On or about June 29, 2021, Ryder saw a veterinarian at Veterinary Care and Specialty Group, who estimated the surgery to correct the issues with Ryder would cost between \$9,800 and \$12,700, and it there was a good chance that it would not be successful. Ryder did not have the surgery and is on pain medications.

Now Therefore, for the purpose of avoiding further administrative action with respect to this cause and pursuant to T.C.A §63-12-106 and Tenn. Comp. R & Regs. 1730-02-.15, Respondent, Thomas Alexander Holt, DVM, license number 4558, agrees to:

Respondent must enroll in and submit proof of completion of six (6) hours of continuing education (CEs) in ethics.

Respondent must enroll in and submit proof of completion of ten (10) hours of CEs in a combination of orthopedic surgery and wound management.

Proof of completion of the CEs must be submitted within one (1) year of ratification of this Order. These CEs are to be in addition to the required hours as set forth in Tenn. Rules and Regs. 1730-01-.12.

Respondent must pay, pursuant to Tenn. Comp. R & Regs. 1730-01-.15 and Board policy, one (1) Type A Civil Penalty of one thousand dollars (\$1,000). Said Civil Penalties must be paid in full within one (1) year of the ratification of this Consent Order.

In addition, Respondent must pay, pursuant to Tenn. Code Ann. §63-1-144, §63-12-143 and Tenn. Comp. R & Regs. Rule 1730-01-.15, the actual and reasonable costs of prosecuting this case to the extent allowed by law, including but not limited to all costs assessed against the Board by the Department's Office of Investigations for this matter. These costs shall be established by an Assessment of Costs prepared and filed by counsel for the Department. The maximum amount for

the assessment of costs shall be two thousand dollars (\$2,000). All costs must be paid in full within sixty (60) days from the issuance of the Assessment of Costs.

Dr. McInturff made a motion to accept the Consent order, with a second from Dr. Garrett. Discussion is as follows: Dr. Galloway inquired if this was an order from the previous meeting that was denied and sent back with recommendation to the attorney's office. Ms. Boone stated that it was an Order from the previous meeting and then gave the previous recommendations that the Board gave to the attorney's office. Mr. Peters stated that they implanted the recommendations to the updated Consent Order.

Dr. Garrett asked about the stipulations of fact as presented in the Consent Order, asking how the break was observed by the medical staff treating the patient.

The motion passed unanimously.

### North Madison Animal Hospital, #825

Respondent has been at all times pertinent hereto licensed by the Board as a veterinary facility in the State of Tennessee, having been granted license/permit number 825 on May 3, 2000, which currently has an expiration date of May 31, 2024.

At all times pertinent hereto Respondent facility was located in Jackson, Tennessee.

On or about May 31, 2020, Respondent's premises permit expired. Respondent's premises permit was renewed on or about September 9, 2022. Between May 31, 2020, and September 9, 2022, the practice of veterinary medicine occurred at Respondent's facility and/or a licensed veterinarian was practicing veterinary medicine when Respondent's permit was expired.

For the purpose of avoiding further administrative actions with respect to this cause, Respondent agrees to the following:

Respondent agrees to pay a Civil Penalty in the amount of two thousand one hundred dollars (\$2,100), which represents \$100 for each of twenty-one (21) months that the facility engaged in the practice of veterinary medicine, beyond the six (6) month grace period, on an expired license/permit.

Respondent understands the ratification of the Consent Order is a formal disciplinary action and will be report to the National Practitioner Data Bank and/or similar agency, as a Civil Penalty. Respondent further understands that a failure to comply with the terms of this order shall constitute grounds for disciplinary action.

Dr. Garrett made a motion to accept the Consent Order, with a second from Dr. McInturff. There was no discussion. The motion passed unanimously.

Dr. Galloway did make a comment that the fees for penalties have been going down The Board's job is not to be punitive, but the goal is that discipline is to change behavior. Dr. McInturff feels

like a punitive measure on a licensee's record is more painful than any amount of money and doesn't necessarily agree with Dr. Galloway's comment.

## Agreed Citation

#### Olivia Thornton, DVM #6903

Dr. Thornton was found to be in violation of TCA 63-12-120, by failing to maintain sufficient continuing education credits, and was short twenty (20) hours during CE audit for calendar year 2020. This deficiency resulted in a civil penalty in the amount of one thousand dollars (\$1.000.00) and the requirement to complete all deficiency hours within 90 days.

A motion was made by Ms. Wereszczak, to approve the Agreed Citation for Olivia Thornton #6903, as written, with a second by Dr. Garrett. The motion passed unanimously.

#### Amanda Hutton, LVMT #1788

Ms. Hutton was found to be in violation of TCA 63-12-120 and Tenn R & Regs 1730-03-.09, by failing to timely renew license. Ms. Hutton practiced on a lapsed license for eight (8) months. This resulted in a civil penalty One Hundred Dollars (\$100.00), and payment must be made within thirty (30) days.

A motion was made by Dr. McInturff, to approve the Agreed Citation for Amanda Hutton #1788, as written, with a second by Ms. Wereszczak. There was no discussion on this motion. The motion passed unanimously.

#### Frances Brokering, LVMT #1587

Ms. Brokering was found to be in violation of TCA 63-12-120 and Tenn R & Regs 1730-03-.09, by failing to timely renew license. Ms. Hutton practiced on a lapsed license for twelve (12) months. This resulted in a civil penalty Three Hundred Dollars (\$300.00), and payment must be made within thirty (30) days.

A motion was made by Ms. Wereszczak, to approve the Agreed Citation for Frances Brokering #1587, as written, with a second by Dr. McInturff. There was no discussion on this motion. The motion passed unanimously.

## Applicant Interviews/File Reviews/Waivers & Other Requests

#### Teresa Priest, DVM

Dr. Priest applied via Reciprocity but had been disciplined by the North Carolina Board of Veterinary Medicine and was issued a letter of Caution in 2010 and a Letter of Reprimand in 2019

that included fines and warranted an interview by the Board and could not be reviewed administratively.

Dr. Priest was present at the meeting to answer questions. Ms. Wereszczak asked Dr. Priest is the practice took any corrective measures to fix the mistake that resulted in the letter of reprimand. Dr. Priest noted the protocol was already in place, but it amplified the level of detail, adding color coded syringe labels in addition to the name labels to help prevent future occurrences.

Dr. McInturff made a motion to approve Dr. Priest for licensure, with a second from Dr. Garrett. There was no discussion on this motion. The motion passed unanimously.

#### Donna Johnson, DVM

Dr. Johnson applied via Reciprocity but had been disciplined by the Colorado Board of Veterinary Medicine and was issued a Letter of Admonition, CE requirements and fines in 2019, and warranted an interview by the Board and could not be reviewed administratively.

Dr. Johnson was present at the meeting to answer questions. There was no discussion on this matter. Dr. McInturff made a motion to approve licensure, with a second from Ms. Wereszczak. The motion passed unanimously.

#### **Knox Edwards**

Mr. Edwards applied for an Animal Euthanasia Technician Certification and answered Yes on his application to taking illicit/illegal drugs within the last two years and this warranted an interview by the Board and could not be reviewed administratively.

Mr. Edwards was present at the meeting to answer questions. Mr. Edwards also produced a letter of support from his employer. The Board expressed their appreciation for Mr. Edwards honesty and inquired if he feels like there is any risk to the animals and citizens of Tennessee by his previous use. Mr. Edwards stated there is no risk.

#### Renee Pitts, LVMT

Ms. Pitts submitted a CE waiver request to be able to take all twelve (12) continuing education hours in an online format due to being out of country.

Ms. Wereszczak made a motion to approve the waiver, with a second from Dr. Garrett. There was no discussion. The motion passed unanimously.

### Lucy Thomason, DVM

Dr. Thomason submitted a CE waiver to be able to complete her 2022 CE in 2023.

Dr. McInturff made a motion to accept the waiver and allow all CE hours to be obtained in an online format for 2022 in 2023, with a second made by Ms. Wereszczak. There was no discussion. The motion passed unanimously.

## **BVME Army Clinics Request**

An IRT, Military Training Mission, submitted information to the Veterinary Board letting them know that they will be completing a veterinary training that will have them assisting the public in Rural Tennessee with Veterinary Services that are going to be provided at a sheriff's office and a local fairground. Mr. Peter's stated to the Board that the inquiry is, does this training fall under the exemption for needing a premises permit.

Dr. Beaty went on to inquire who was liable if there was an issue with any of the animal after the training process because the IRT that the military provided has a section about harmless agreement, meaning they are not liable.

Dr. Galloway stated that he's unsure if the BVME has any jurisdiction over this since it's a training directive from the Federal Government. Mr. Peters stated that they are required to reach out and notify local licensing boards of the training but went back to the original questions on if this IRT makes them exempt from needing a premises permit.

Dr. McInturff's only issue with stating they were exempt from needing a premises permit was, after the training was done, who was there if any follow care was needed. The Board placed a call to LTC Brian Collins, DVM, DACVPM, LTC, VC to inquire who would be in charge of follow up care in case of complications. Dr. Collins stated that the local practitioners and Emergency clinics would be made aware of follow up care and would be the ones to issue any if necessary. Dr. Beaty then followed up with whom would be liable if any problematic or grievances are issued. Dr. Collins noted that all the veterinarians participating in this training do hold individual state license's elsewhere if not in TN and they would be individually responsible. Ms. Wereszczak inquired if this training has occurred in other states, which Dr. Collins stated is has been conducted in other states.

Dr. McInturff made a motion to give them the exemption for needing a premises permit, with a second by Dr. Garrett. The motion passed unanimously.

# Ratification of Licensure Files

Ms. Wallace informed the Board that the files presented on the Ratification List have been reviewed and found complete and in good order according to the rules for new licensure, reinstatement of license, facility premises permits and the closure of incomplete files.

Ms. Wereszczak made a motion to approve the Ratification List for new licenses, reinstated licenses, and closed/withdrawn files, as written, with a second made by Dr. McInturff. There was no discussion on the motion. The motion passed unanimously.

### **Review of Correspondence and Notices**

#### Notice – FDA via AAVSB: GFI #269

The AAVSB submitted a notice from the FDA about the withdrawal of the guidance document entitled "Enforcement Policy Regarding Federal VCPR Requirements to Facilitate Veterinary Telemedicine During the COVID-19 Outbreak," which was issued in March 2020. FDA is withdrawing this guidance document in recognition that the conditions that created the need for the enforcement policy have evolved, such that the policy is no longer needed.

#### Notice - FDA via AAVSB: GFI #152

The AAVSB submitted a notice from the FDA about a draft update to guidance for industry (GFI) #152, "Evaluating the Safety of Antimicrobial New Animal Drugs with Regard to Their Microbiological Effects on Bacteria of Human Health Concern." The guidance is a tool for assessing the risk of antimicrobial resistance (AMR) in people, which could result from the use of a medically important antimicrobial drug in food-producing animals. The scope and purpose of updated GFI #152 remains the same as the initial version of the guidance issued in 2003. Updates to the guidance include revisions to the risk assessment framework, updated ranking criteria for determining the degree of medical importance of antimicrobial drug classes, and a revised ranking of antimicrobial drug classes as critically important, highly important, or important based on the newly updated ranking criteria (Appendix A).

# **Conference/Event Reports and Upcoming Events**

Dr. Galloway made a motion to sponsor 1 Board Member, 1 Administrative Staff and 1 Attorney to attend the AAVSB Annual Meeting and Conference on September 28, 2023 – September 30, 2023, with a second by Dr. McInturff. No discussion. The motion passed unanimously.

A request for the Board Inspector's to have ID Badges from the Department of Health so they can present them at inspections at a facility.

Dr. Baron asked to educate the Board on drug diversion. Went over the addictiveness of Tramadol and that it's important to look for addiction when large amounts of drugs are missing. Dr. Baron noted for someone being referred to them, they are sent for an extensive evaluation to determine if there is a drug related issue or not. If they are determined to have a substance abuse disorder, they are sent for treatment and Board Orders may include monitoring with a minimum or five (5) years in most cases. TMF has a high rate of success.
