This ESRD facility is seeking to temporary place their license on inactive status pending the resolution of staffing issues faced by this and other area facilities. A list detailing where patients will receive their treatments during the temporary closure has been identified. Camden Dialysis intend to reduce staffing pressure at several area clinics via consolidation of qualified personnel into fewer locations. A recent COVID surge necessitated this plan, as the surge has abruptly interrupted our staffing availability due to personal illness and increased demand for patient cohorting. Camden Dialysis anticipate the facility will resume services on or about April 30, 2022, but that date could be subject to change, either moving forward or backward, due to circumstances currently outside of our control.

Dr. Warhaftig expressed it would help Vanderbilt to maybe do this once every six (6) months and not every meeting. Ms. Felts explained the way Vanderbilt does reporting the in-person presentation would take place at the April and October Board meetings. Mr. Dunn made a motion to accept that the reporting will be presented every six (6) months; Ms. Warhaftig seconded. Ms. Reed expressed every six (6) months would coincide appropriately. Mr. Dunn amended his motion to approve the reporting be done in the months of April and October. Ms. Peach seconded. This amendment to the motion was approved.
