## **Approval of Minutes**

Ms. Strong made a motion, seconded by Dr. Simpson, to approve the April 5, 2017 minutes. The motion carried.

# **Investigations and Disciplinary Report**

Page 1 of 14 Board of Veterinary Medical Examiners August 16, 2017 Ms. Dorsey Luther, Disciplinary Coordinator, reported there are currently nineteen (19) open complaints in the Office of Investigations. Ms. Dorsey also provided a list of practitioners currently being monitored for compliance with disciplinary orders.

## **Applicant Interviews**

## Joseph A. Crouch, C.A.E.T.

The Board reviewed an application for certification as an animal euthanasia technician submitted by **Joseph Crouch.** Mr. Crouch answered "no" to the question on the application regarding conviction of any felony or misdemeanor. Mr. Crouch was present to answer any questions from members of the board regarding a 2010 conviction for Driving on Suspended License; a 2011 Failure to Appear conviction; and a 2013 Violation of Probation. Upon discussion and review of the documentation, Ms. Strong made a motion, seconded by Dr. Ladd, to approve the application. The motion carried.

## Mary A. Gardner, D.V.M.

The Board reviewed an application for licensure by reciprocity as a veterinarian submitted by **Mary A. Gardner, DVM**. The board deferred action on Dr. Gardner's application file at the April 5, 2017 meeting and requested Dr. Gardner's appearance at this meeting. Dr. Gardner answered "no" to the question on the application regarding any disciplinary action in another state. Licensure verification received from the Texas Board of Veterinary Medical Examiners indicated disciplinary action in 2014 for unlicensed practice. Dr. Gardner was present to answer any questions from members of the board. After discussion and review of the documentation, Dr. Simpson made a motion, seconded by Dr. Ladd, to approve the file. The motion carried.

## Josephine Lowery, C.A.E.T.

The Board reviewed an application for certification as an animal euthanasia technician submitted by **Josephine Lowery.** Ms. Lowery answered "yes" to the question on the application regarding conviction of any felony or misdemeanor. Ms. Lowery was present to answer any questions from the members of the board regarding a 2003 Criminal Trespass conviction; a 2003 Harassment conviction; and a 2004 Assault – Physical Contact conviction. Mr. Jack Cooper, Supervisor, Bedford County Animal Control, spoke on her behalf. Upon discussion and review of the documentation, Dr. Simpson made a motion, seconded by Dr. Thompson, to approve the application. The motion carried.

## Christina R. Hodge, C.A.E.T.

The Board reviewed an application for certification as an animal euthanasia technician submitted by **Christina R. Hodge.** Ms. Hodge answered "no" to the question on the application regarding conviction of any felony or misdemeanor. Ms. Hodge was present to answer any questions from the members of the board regarding convictions in 1997, 1998, and 2002 for

Insufficient Funds Checks. Upon discussion and review of the documentation, Dr. Ladd made a motion, seconded by Ms. Strong, to approve the application. The motion carried.

## Shana True, L.V.T.

The Board reviewed an application for licensure as a veterinary technician submitted by **Shana True, L.V.T.** Ms. True was not present. Dr. Federico recused himself. Ms. True answered "no" to the question on the application regarding conviction of any felony or misdemeanor. Ms. True had a 2003 conviction for Possession of Drug Paraphernalia and a 2003 conviction for Criminal Trespassing. Upon discussion, Dr. Ladd made a motion, seconded by Ms. Strong, to defer action on the file and to request Ms. True's presence at the next board meeting. The motion carried.

## Elizabeth Croy, L.V.T.

The Board reviewed an application for licensure by reciprocity as a veterinary technician submitted by **Elizabeth Croy, L.V.T.** Ms. Croy was present to answer any questions from members of the board. Rule 1730-03-.04(2)(d) requires proof of engaging in active practice as a veterinary technician in another state for one out of the last five years preceding application. Ms. Croy has not been engaged in "active practice" for the previous five (5) years and requested a waiver of this requirement. Ms. Croy holds an active license in good standing in the state of Ohio. Upon discussion, a motion was made by Dr. Simpson, seconded by Ms. Strong, to grant a conditional license. Ms. Croy must obtain and complete twelve (12) hours of approved continuing education by December 31, 2018 and submit proof of same to the Board's administrative office. Such hours are in addition to the twelve (12) continuing education hours required each calendar year under Rule 1730-03-.12(1)(a). The motion carried.

# Presentation by Michael Baron, MD, MPH, Medical Director, Tennessee Medical Foundation (TMF) – Physician Health Program (PHP)

Dr. Baron made a brief presentation to the Board regarding the TMF-PHP. The mission of the Physician's Health Program (PHP) is to protect patients through identification, intervention, rehabilitation, and the provision of advocacy/support for physicians impaired by addictive disease, mental or emotional illness. The TMF-PHP also provides help to other healthcare professionals, including veterinarians, with the following issues:

Alcohol or Drug Dependency Disruptive Behavior Boundary Issues Psychiatric Disorders Stress Issues Cognitive Deficits

The Board expressed their appreciation to Dr. Baron and suggested that he also contact the Tennessee Veterinary Medical Association regarding the Physicians Health Program.

# **Office of General Counsel (OGC) Report**

Ms. Caroline Tippens, Assistant General Counsel, reported the Office of General Counsel has twelve (12) open cases pertaining to the Board of Veterinary Medical Examiners. There are two (2) Consent Orders and one (1) Agreed Order to be presented at this meeting.

The proposed rule amendments are currently in internal review. The Board requested and reviewed a copy of the proposed rules.

One of the Department's legislative liaisons will be giving a presentation regarding legislation affecting the Board.

# Agreed Order – Susan C. Rogers-Scarlett, D.V.M.

Dr. Rogers-Scarlett was not present and was not represented by counsel. Ms. Caroline Tippens, Assistant General Counsel, presented the Agreed Order to the Board for ratification. Dr. Rogers-Scarlett practiced in a veterinary facility without a premises permit from about January 31, 2010 to October 25, 2016. Dr. Rogers-Scarlett agreed to pay total civil penalties in the amount of three thousand five hundred dollars (\$3,500.00). Dr. Simpson made a motion, seconded by Dr. Thompson, to accept the Agreed Order. The motion carried.

# **Consent Order – Richard S. Thompson, D.V.M.**

Dr. Thompson was present and was not represented by counsel. Ms. Caroline Tippens, Assistant General Counsel, presented the Consent Order to the Board for ratification. Dr. Thompson practiced in a veterinary facility without a premises permit from about November 30, 2006 to March, 2017. Dr. Thompson agreed to pay total civil penalties in the amount of six thousand dollars (\$6,000.00). Dr. Simpson made a motion, seconded by Ms. Strong, to accept the Consent Order. The motion carried.

# Consent Order – Guy R. Sanders, D.V.M.

Dr. Sanders was present and was not represented by counsel. Ms. Caroline Tippens, Assistant General Counsel, presented the Consent Order to the Board for ratification. Dr. Sanders practiced in a veterinary facility without a premises permit from about January 31, 2006 to March, 2017. Dr. Sanders agreed to pay total civil penalties in the amount of six thousand five hundred dollars (\$6,500.00). Dr. Simpson made a motion, seconded by Ms. Strong, to accept the Consent Order. The motion carried.

# **Order of Compliance – Campbell County Animal Control, C.A.C.A.**

Ms. Dorsey Luther, Disciplinary Coordinator, presented the Order of Compliance to the Board. Mr. E. L. Morton, Mayor, Campbell County, was present. Dr. Thompson made a motion, seconded by Ms. Strong, to lift the probation and approve the Order of Compliance. The motion carried.

# **Order of Compliance – Memphis Animal Services, C.A.C.A.**

Ms. Dorsey Luther, Disciplinary Coordinator, presented the Order of Compliance to the Board. Ms. Alexis Pugh, Director, Memphis Animal Services, was present. Dr. Simpson made a motion, seconded by Ms. Strong, to lift the probation and approve the Order of Compliance. The motion carried.

## Controlled Substances Monitoring Database (CSMD) Advisory Committee

Board members reviewed the upcoming CSMD Committee meeting dates. Dr. Ladd volunteered to attend the October 17, 2017 meeting if Ms. Walsh was unable to attend as scheduled. The Board requested that the 2018 meeting dates be placed on the agenda for discussion at the next board meeting.

## Legislative Update

Mr. Jim Layman, JD, Legislative Liaison, reviewed the following legislation:

# Public Chapter 44

This sunset provision extends the board of veterinary medical examiners until June 30, 2021.

## Public Chapter 274

This specifies that the practice of veterinary medicine does not include massage therapy to animals, which means the manipulation of the soft tissues of the animal body with the intention of positively affecting the health and well-being of the animal. Massage therapy does not include the diagnosis, treatment, correction, alleviation, or prevention of any animal disease, illness, pain, condition, etc. This law became effective on May 4, 2017, but will expire on July 1, 2018.

## Public Chapter 350

This will allow healthcare providers to satisfy one hour of continuing education requirements through the performance of one hour of voluntary provision of healthcare services. The maximum amount of annual hours of continuing education that a provider can receive through providing volunteer healthcare services is the lesser of 8 hours or 20% of the provider's annual continuing education requirement. The legislations allows for rulemaking by the division of health related boards in order to administer this section. This took effect on May 12, 2017.

## Public Chapter 215

This will require state governmental entities that establish or adopt guides to practice to do so through the promulgation of rules, rather than policy. The rules so promulgated must specify all provisions included in and relating to the guide to practice. Any changes to guides to practice

Page 5 of 14 Board of Veterinary Medical Examiners August 16, 2017 made after the guides are adopted must also be promulgated by rule in order to be effective. For purposes of this part, guides to practice includes codes of ethics and other quality standards, but does not include tests, examinations, building codes, safety codes, or drug standards. This legislation took effect on April 28, 2017.

# Public Chapter 240

This legislation was brought by the Department of Health and was designed to address a number of issues throughout all licensing boards, committees, and councils. This legislation will:

- Insure the integrity of licensure examinations by making examination questions, answer sheets, scoring keys, and other examination data confidential and closed to public inspection.
- Allow the issuance of limited licenses to applicants who have been out of clinical practice or inactive, or who are engaged in administrative practice. Limited licenses may be of restricted scope, restricted duration, and have additional conditions placed upon them in order to obtain full licensure.
- Clarify that other documents prepared by or on behalf of the Department with regard to an investigation are confidential until such time as formal disciplinary charges are filed against the provider.
- Eliminate the "locality rule" for administrative law.
- Require the chief administrative official for each health care facility to report within 60 days any disciplinary action taken against an employee for matters related to ethics, incompetence or negligence, moral turpitude, or substance abuse, to the employee's respective licensing board. All records pertaining to the disciplinary action shall be made available for examination to the licensing board.

This act became effective on May 2, 2017.

# Public Chapter 230

This legislation authorizes commissioners or supervising officials of departments to evaluate certain actions by a regulatory board to determine whether the action may constitute a potentially unreasonable restraint of trade. Supervising officials must ensure that the actions of regulatory boards that displace competition are consistent with a clearly articulated state policy. If a board action constitutes a potentially unreasonable restraint of free trade, the supervising official must conduct a further review of the action and either approve, remand or veto the action. The supervising official may not be licensed by, participate in, or have a financial interest in the occupation, business or trade regulated by the board who is subject to further review, nor be a voting or ex officio member of the board. The supervising official must provide written notice of any vetoed actions to the senate and house government operations committees.

Prior to filing a regulatory board's rule with the secretary of state, the commissioner or chief executive officer of the administrative department under which a regulatory board operates or to which a regulatory board is administratively attached, or a designee to the extent a conflict of interest may exist with respect to the commissioner or chief executive officer, must remand a rule that may constitute a potentially unreasonable restraint of trade to the regulatory board for additional information, further proceedings, or modification, if the rule is not consistent with a

Page 6 of 14 Board of Veterinary Medical Examiners August 16, 2017 clearly articulated state policy or law established by the general assembly with respect to the regulatory board. This act took effect on April 24, 2017.

## **Discussion – Public Chapter 274**

This legislation specifies that the practice of veterinary medicine does not include massage therapy to animals. This law became effective on May 4, 2017, but will expire on July 1, 2018.

Upon further review and discussion of this bill, the Board feels that Public Chapter 274 is in conflict with the intent and purpose of the Board and has serious concerns that the legislation, as currently written, will negatively impact the health and welfare of the animals and the citizens in the state of Tennessee. The Board requested that a letter be sent to the sponsors of the legislation requesting the opportunity to have input into any further legislation in order to ensure that a rational and functional framework can be formulated going forward.

## **Inspection Status Report**

A total of one hundred fifty-three (153) inspections were conducted during the period of March 2017 thru July 2017.

## **Director's Report**

Ms. Lampley expressed her appreciation to Dr. Federico, Dr. Johnson, and Ms. Walsh for their service and contributions to the Board. Their terms expired 07/31/16 and their willingness to continue to serve until a replacement member is appointed is greatly appreciated.

Ms. Lampley spoke about the licensure process to the graduating students of the veterinary technology programs at Chattanooga State Community College, Columbia State Community College, and UT – Martin during the month of April.

The next testing window for the North American Veterinary Licensing Examination (NAVLE) will be November 13 – December 09, 2017. The application deadline was August 1<sup>st</sup>. We have received approximately one hundred and five (105) licensure applications from candidates wishing to take the exam through our licensing board. These numbers increased this year due to LMU's first graduating class of veterinary students.

# **Continuing Education Audit Report**

A total of forty-five (45) veterinarians were audited during the period of July 2016 thru June 2017. Eight (8) licensees were found to be non-compliant with continuing education requirements. A total of twelve (12) veterinary technicians were audited during this same period. One (1) licensee was found to be non-compliant with continuing education requirements.

The Board expressed some concerns regarding the 82% compliance rate for veterinarians.
