Dear Mr. Harris:

The Department of Human Services (DHS) Audit Services staff conducted an on-site unannounced review of the Child and Adult Care Food Program (CACFP) at Martin Housing Authority (Sponsor), Application Agreement 00048, on May 22, 2017. We reviewed the sponsor's records of reimbursements and expenditures for April 2017. The purpose of this review was to determine if the Sponsor complied with *Title 7 of the Code of Federal Regulations* (CFR) applicable parts, application agreement, and applicable Federal and State regulations.

<u>Background</u>

CACFP sponsors utilize meal count sheets to record the number of meals served for breakfast, lunch, supper and supplement meals served. Meals served by participating sponsors must meet the minimum guidelines set by the United States Department of Agriculture (USDA) and DHS to be eligible for reimbursement. The CACFP sponsor reports the number of meals served through the DHS Tennessee Information Payment System (TIPS) to seek reimbursement. We inspected meal count sheets for our test period and reconciled the meals claimed to the meals reported as served for each meal service. We also assessed compliance with civil rights requirements and observed a meal service on April 12, 2017.

There were two feeding sites operating during the test month of April 2017. The Learning Enrichment Center site was selected as the sample site.

Our review of the sponsor's records for the test month of April 2017 disclosed that there were no significant deficiencies.
