The Department of Human Services (DHS) - Division of Audit Services staff conducted an unannounced on-site monitoring review of the Child and Adult Care Food Program (CACFP) at Best Beginnings Preschool (Sponsor), Application Agreement number 00-159, on December 13, 2018.
