Dear Mr. Alexander.

The Department of Human Services (DHS) - Division of Audit Services staff conducted an unannounced on-site monitoring review of the Child and Adult Care Food Program (CACFP) at LBJC Development Corporation (Sponsor), Application Agreement number 00-378, on January 8, 2019. The purpose of this review was to determine if the Sponsor complied with the *Title 7 of the Code of Federal Regulations* (CFR) applicable parts, provider agreement, and applicable Federal and State regulations.

Based on our review of the Sponsor's records and information provided, the Sponsor had 19 head start sites operating during the review period. The **Gainsboro Head Start**, **Shiloh Head Start**, and **Smith County Head Start** sites were selected as the sample.

Our review of the Sponsor's records for November 2018 revealed no significant deficiencies.
