Treasurer Sims brought up from the floor the matter regarding a grant to the City of Spencer. He said that, a year ago, Judge Haynes opined that the SBC does not have oversight of the project and an appeal has been filed by the State and is pending. He added that Judge Haynes has issued an order mandating that the Commissioner of Finance & Administration execute a grant between the State and City of Spencer and disburse funds accordingly. Treasurer Sims stated that he believed the State should continue to aggressively pursue this appeal, and that this is a grant over which the SBC has jurisdiction. He said he doesn't want to see Commissioner Fyke and Commissioner Goetz in contempt of court. Treasurer Sims acknowledged that the State was working through the steps that needed to be taken. He added that he thought it was important for the City to understand that, should the State prevail, it would be the intent of the State to have the right to collect those funds disbursed under that grant, and for them to move forward was not without risk. Commissioner Fyke responded that he would make sure the City understands that. Treasurer Sims ended by saying that the appeal should be aggressively pursued, as the underlying issue of SBC authority is paramount.


