Advanced Placement Course Update to Board Policy 3.205

The Background:

Advanced Placement (AP) courses are proprietary curricula developed by the College Board and taught as rigorous, college-level courses in high schools across the country. These rigorous courses are aligned with AP Exams, through which students can earn college credit if they meet or exceed the score(s) accepted by the institutions of their choice. All University of Tennessee and Tennessee Board of Regents institutions award credit based on student performance on AP exams.

The courses listed in the Approved High School Courses (Board Policy 3.205) need to be updated to reflect the current offerings of AP courses by the College Board. This item recommends adding courses that have not previously been included in this policy, and removing courses that have been retired by the College Board within the Approved High School Courses (Board Policy 3.205). Additionally, this item recommends listing each of the AP courses offered by the College Board separately, rather than within general areas (e.g., Macroeconomics and Microeconomics instead of Economics).
