The item would allow Tennessee educators with a license to earn an additional endorsement by completing an additional endorsement program developed and administered by the Tennessee Department of Education, receiving recommendation for endorsement by the Department, and submitting qualifying scores on all required content assessments. Mr. Michael Deurlein, Senior Director of Educator Licensure and Preparation with the Tennessee Department of Education, presented the item. Commissioner Schwinn made comments in support of the policy and stated that the Department would work to answer questions posed by members of the State Board of Education before the policy came before the Board of Education's next quarterly meeting in July 2021. Members of the Board initially tabled the item for further discussion until the next quarterly meeting. After discussion, members lifted the item from the table and voted by a roll call vote.
