## Career and Technical Education (CTE) Courses and Standards

## The Background:

T.C.A. § 49-1-302(a)(8) authorizes the State Board of Education to "set policies governing all academic standards and courses of study in the public schools." Additionally, State Board Rule 0520-01-03-.05(1) calls for the State Board to adopt standards for each subject area, grades K-12. The approved standards are to be the basis for planning instructional programs in each local school system.

This item includes new and revised course standards for the following CTE career clusters:

- Agriculture, Food, and Natural Resources
- Architecture and Construction
- Education and Training
- Government and Public Administration
- Human Services
- Marketing, Distribution and Logistics

The high school CTE course standards format has also been updated based on educator feedback for ease of use and to align more closely with competency-based industry and postsecondary standards.

These new and revised standards have been reviewed by industry, secondary, and postsecondary partners. Additional feedback will be solicited between first and final reading. Pursuant to T.C.A. § 49-1-309, the State Board will submit the proposed changes to the education committees of the House and Senate prior to final reading. These CTE course and standards changes will go into effect for the 2022-23 school year.
