

Annual Report to the Tennessee School Board regarding:

Restraint and Isolation Data

School years 2012-2013, 2013-2014, 2014-2015, and 2015-2016

Presented by the Governor's Advisory Council for the Education of Students with Disabilities

Tennessee Code at 49-10-1306 (e) [Attachment A] states that each local education agency shall submit information to the department of education each year on the use of isolation and restraint in the school district. This data [Attachment B] shall be reported to the state Advisory Council for the Education of Students with Disabilities. The Council shall use this information to report annually to the State Board of Education with recommendations to reduce the use of isolation and restraint in public education programs. The State Board of Education shall use these recommendations as well as data, documentation and reports to establish policy or strategies or both to reduce or eliminate the use of isolation and restraint in schools.

The Advisory Council formed a committee specifically to review and examine the reported restraint and isolation data, and prepare a recommendation for the State Board to act upon. The Advisory Council is also represented on a task force the state formed for the purpose of discussing the restraint/isolation data.

The Council did not come to the State Board with recommendations after the first year data was collected because 1 year of data was not enough to make decisions based upon. This report, originally presented to the State Board last year, has been updated with data from 2015-2016.

At the Advisory Council meeting on July 14, 2014, Rachel Wilkinson, State DOE Special Populations, said regarding data in general:

“Give a couple years to get a baseline. It is unfair to take data never collected before and put some sort of prescriptive comments on that.”

During the consideration and evaluation of data provided to us, the Advisory Council, via participation on the task force, received accounts of restraint/isolation being reported that, under the law, would not meet the definition of restraint/isolation and should not have been reported or included in the data. This inflated the numbers and made it impossible to draw any conclusions from the data. A logical assumption would be that it is probable that some restraint/isolation that should have been reported may not have been reported at all. This further “clouded” the data.

All who examined the reported data agreed that we would have “cleaner” data if individuals understood what is and what is not a restraint/isolation and under what circumstances to employ either. A side effect of increased understanding is that there would be fewer incidences of

restraint/isolation if people understood the *what*, the *why*, and the *when* of restraint/isolation, and applied them appropriately.

The law is clear about what is to be reported, the state report form conforms to the law. A suggestion was made to expand the report form to include many additional fields. It was pointed out that, in an effort to gather cleaner data, gathering “more” data may not improve the chances of getting more accurate data. To get more accurate data, you educate people on what is being sought and how to report it, you don’t require more data.

Errors in reporting data can occur in even the most simple of fields. For example, the state report form asks if school personnel died as a result of employing a restraint. The default is “no”. If you do not click anything in the computerized reporting form, it reports “no”. To report “yes” (a death of school personnel), you must use the mouse and “click” the drop down menu and then “click” “yes”. In one reporting year, 17 school personnel were reported to have died, in error.

The Advisory Council’s recommendation for how to address the identified need for more accurate information and increased understanding is to create a document and disseminate it to school systems and place it on the state web site for parents and other concerned individuals to access.

It is the recommendation of the Advisory Council that this document should be in a Question and Answer format. The purpose of this document is to inform and educate as to the requirements of the law; the *what*, the *why*, and the *when*, not the *how*. The history and background of how the restraint law came to be and “best practice” recommendations are not recommended to be included in the document. This should be an informational document that individual school systems may choose to use in restraint and isolation trainings. State regulations speak to restraint and isolation “training” being up to the individual school system.

Rule 0520-01-09-.23

(2) Local education agencies are authorized to develop and implement training programs that include:

- (a) Use of positive behavioral interventions and supports;
- (b) Nonviolent crisis prevention and de-escalation;
- (c) Safe administration of isolation and restraint; and
- (d) Documentation and reporting requirements.

(3) Local education agencies are authorized to determine an appropriate level of training commensurate with the job descriptions and responsibilities of school personnel.

(4) Local education agencies shall develop policies and procedures governing:

- (a) Personnel authorized to use isolation and restraint;
- (b) Training requirements; and
- (c) Incident reporting procedures.

A Q&A document, such as the one proposed, that explains the law and helps systems understand restraint/isolation and the appropriate use of both will afford an opportunity for systems to develop and provide more effective training; more effective training will result in more appropriate application of the law, resulting in fewer incidences of restraint and isolation, and yield more accurate data that will enable us to make future recommendations.

The Council believes that this is a logical first step, and an appropriate recommendation at this time. Other options considered included webinars, email, and face-to-face training opportunities. The recommendation is to educate persons on what the law says and requires via a Q&A document; and it is believed that a better understanding of the law and required reporting procedures will yield better data and should result in fewer incidents of restraint and isolation. Data collected in future years should help us identify future needs, which may require additional/different recommendations as we endeavor, together, to reduce or eliminate the use of isolation and restraint in schools.

Additionally, the committee does not feel that any changes to the report form, state regulations, or state law is warranted at this time.

If the State Board adopts the recommendation of the Advisory Council, the Advisory Council would like to volunteer to be involved in the development, creation, and editing of any document prior to it being made available to stakeholders in Tennessee.

Attachment A

49-10-1306. Promulgation of rules and regulations.

- (a)** Each school shall maintain all records of isolation and restraint.
- (b)** On a semiannual basis, using existing student-level data collection systems to the extent feasible, each school shall submit a report to the local education agency that includes:
 - (1)** The number of incidents involving the use of isolation and restraint since the previous semiannual report;
 - (2)** The number of instances in which the school personnel imposing physical restraint or isolation were not trained and certified;
 - (3)** Any injuries, deaths, or property damage that occurred;
 - (4)** The timeliness of parental notification; and
 - (5)** Demographic information to determine whether disproportionate use of these interventions exists.
- (c)** The local education agency shall use the information obtained from records of isolation and restraint in developing its behavior intervention training program.
- (d)** The local education agency shall submit information to the department of education each year on the use of isolation and restraint in the school district.
- (e)** Annually, this information shall be reported to the state advisory council for the education of students with disabilities established pursuant to § 49-10-105. This information must also be made readily available to the public. The council shall use this information to report annually to the state board of education with recommendations to reduce the use of isolation and restraint in public education programs. The state board of education shall use these recommendations as well as data, documentation and reports to establish policy or strategies or both to reduce or eliminate the use of isolation and restraint in schools.
