Dear Chairman Carter and Dr. Lippard,

I wanted to share with you the attached letter from Commissioner Schwinn and Dr. Sara Morrison regarding your memo dated May 23rd, 2018, along with a spreadsheet detailing the variance which would occur under the proposed TACIR formula. While the changes you propose appear meritorious, the authority to make these changes appear to be either within the purview of TACIR, or within the authority of the General Assembly. It has also been brought to my attention that the statutory authority under which TACIR operates is extensive, and specifically authorizes that distinguished body to bring bills and even constitutional amendments to actuate its recommendations. This authority well exceeds that of the BEP Review Committee, and would seem to create a clear path forward for TACIR in accomplishing this recommendation. Last year the committee postponed consideration of the TACIR recommendation until this year. As Chairman I am happy to bring it back up as an agenda item at our upcoming in person meeting if it is still the desire of TACIR to do so. We appreciate the continued partnership of TACIR.
