* Davidson County's contract with the State allows for locally sentenced inmates to be paid for at actual costs, as determined by the operating cost of the detention center, regardless of housing location within the county, without a cap. \$57.85 is the actual cost for locally sentenced inmates across all facilities in FY16. The state reimburses the county \$37 per day for backup inmates at all facilities.

** In FY16, the contract to house locally sentenced inmates at Shelby County Correctional Center was for actual costs, but capped at \$67.46 per day. The contract was amended effective 7/1/16 to pay actual costs up to a maximum of \$73.00 per day for locally sentenced inmates. All other state inmates (e.g. backup) at SCCC are paid at \$37.00 per inmate day. Inmate days at Shelby County's other jail facility are reimbursed at \$37.00 per day.
