The additional staff will enable engineering to provide improved service and greater attention to the airports by redistributing the airports across seven (7) project managers and focusing more heavily on planning. In changing some of the airport assignments, there are several factors that we accounted for. These include:

- fostering existing relationships,
- considering PM competencies,
- minimizing disruption,
- balancing workload, and
- reducing geographical spread.

In order for the PMs to efficiently travel and maintain a regular presence at their airports, their assignments need to be closely grouped geographically. This wasn't the case before for several PMs.

The new airport assignments are detailed in the attached PDF. As we make these changes, we recognize the importance of communication and inclusion of all relevant staff. To support that, the list includes the respective Supervisor, Program Monitor, and former PM, if applicable. When applicable, 1) Cc the Project Manager's supervisor and 2) Additionally, Cc the former PM (indicated in **Bold** below the airport name).

The transition period will last as long as is needed to ensure that each PM is knowledgeable about their airports and is capable of executing projects. We suspect this will vary on a case-by-case basis. The transition for the new assignments may seem tough at first, but it is necessary and we're confident that we will all benefit from it in the long run.
