Reason for Project

Current Conditions

- 2 lane highway
- 2023 Average Daily Traffic: 20,457

Future Conditions:

- 2 travel lanes in each direction, center turn lane, bike lanes, and sidewalks
- 2043 Average Daily Traffic: 35,994

Project Elements:

- 7 Retaining Walls
- 3 Box Culverts
- 3 Stream Relocations
- Roadway Lighting / Signalization

Traffic Control

- Some side road closures will occur throughout the life of the project.
- Expect temporary lane closures and flagging operations for some construction activities.
- Detours will be implemented as needed.





Lane Closures

- Temporary lane closures on SR-11 shall only be allowed from 9:00 AM to 3:00 PM during weekdays. Temporary lane closures during weekends are allowed at any time expect for Sundays before noon.
- During phase one, only one (1) side road is allowed to be closed at any given time.
- During phase two, only one (1) of the following side roads are allowed to be closed at any given time: Porter House Dr., Persia Way, and Sugar Valley Drive.
- No lane closures will be allowed during Special Events, Holidays, or Holiday weekends in accordance with the plans and specifications, or as directed by the Engineer.













Celebration Way Intersection
