To: TennCare/DOE Task Force From: TennCare Provider Services Date: November 07, 2017 **Subject: Provider Registration for a Group Provider**

For the purpose of this memo, each local Department of Education is considered to be a "multispecialty group" provider (ie; a "multi-specialty" group of occupational therapists and/or speech therapists and/or physical therapists).

In order to be paid for medically necessary covered services provided to Medicaid/TennCare eligible members, all Healthcare Provider Organizations must:

- **1.** Apply for and obtain a Type II National Provider Identifier (NPI)
 - Information on how to apply is at: <u>https://www.cms.gov/Regulations-and-</u> <u>Guidance/Administrative-Simplification/NationalProvIdentStand/apply.html</u>.
 - A national provider identifier (NPI) is a unique ten-digit identification number required by HIPAA for all health care providers in the United States.
 - Providers must use their NPI to identify themselves in all HIPAA transactions.
- **2.** Apply for and obtain a TennCare/Medicaid ID number.

 - Multi-specialty groups should select Taxonomy code 193200000X during the registration process.
