Schedule for upcoming Provider Stakeholder Group Meetings

- Remaining meetings scheduled in 2018 will continue on the regular monthly schedule.
- Beginning January 2019, Provider Stakeholder Group meetings will be scheduled quarterly.



Care Coordination Tool-Admissions, Discharges, and Transfers (ADT) Update

As of 9/21/18, the following ADT statistics are accounted for in the Care Coordination Tool (CCT):

- 80% of hospitals statewide
- 80% of licensed hospital beds statewide
 - 18 health systems live
 - 119 hospitals live
 - Over 19,000 hospitals beds live



Results of Episodes of Care Program

CY 2015

Estimated Savings*:

\$10.8 million

- Providers and hospitals reduced costs while maintaining quality of care
- Gain sharing payments to providers exceeded risk sharing payments by \$280,000

Episodes included: perinatal, total joint replacement (TJR), acute asthma exacerbation

CY 2016

Estimated Savings*:

\$14.5 million

- Quality metrics improved for perinatal, total joint replacement, and COPD, and were mostly maintained for the remaining episodes
- Gain sharing payments to providers exceeded risk sharing payments by \$395,000

Episodes included: perinatal, TJR, acute asthma exacerbation, colonoscopy, acute PCI, non-acute PCI, cholecystectomy, COPD

CY 2017

Estimated Savings*:

\$28.6 million

- Quality metrics improved or maintained for most episodes
- Gain sharing payments to providers exceeded risk sharing payments by \$202,557

Episodes included: perinatal, TJR, acute asthma exacerbation, colonoscopy, acute PCI, non-acute PCI, cholecystectomy, COPD, GI Hemorrhage, EGD, Respiratory Infection, Pneumonia, UTI outpatient, UTI inpatient, CHF, ODD, CABG, Valve, Bariatric





SAVINGS RESULTS

Episodes estimated savings for 2017 is approximately <u>\$28.6</u> million due to episodes' risk-adjusted cost being less than projected medical trend of a 3% annual increase
