MINUTES

TENNESSEE HIGHER EDUCATION COMMISSION Spring Quarterly Meeting April 15, 2004, 1:30 p.m. CDT

The meeting was called to order by Chairman Jim Powell with the following Commission Members present:

Approval of Minutes, November 20, 2003 Meeting

Mr. Powell asked for a motion to approve the minutes of the January 29, 2004, Commission meeting. Dr. Brad Windley made the motion which was seconded by Mr. Dale Sims. The motion was duly adopted.

Adoption of Agenda

Mr. Powell called for a motion to adopt the agenda. The motion was made by Mr. Ransom Jones and seconded by Ms. Debby Koch. The motion was duly adopted.

Chairman's Report

Mr. Powell began his report by acknowledging the efforts of the Tennessee Board of Regents in reducing expenditures for its recent meeting at East Tennessee State University by over \$20,000. He encouraged Chancellor Charles Manning to continue with these cost saving measures.

Mr. Powell reported on the success of the work session held earlier in the day and noted that although all agenda items were not covered, each of the major topics were addressed. He further apprised the Commission of the formation of an ad hoc committee whose purpose is to become more informed on the nature of work performed by the Commission staff. The committee is chaired by Ms. Katie Winchester and also includes General Wendell Gilbert and Mr. Jones. After an initial meeting with staff in Nashville, Mr. Powell indicated that subsequent meetings would be held monthly via telephone conferences in the same fashion as the regular monthly committee meetings.

Executive Director's Report

Dr. Richard Rhoda began his report by welcoming president emeriti, Dr. Roy Nicks and Dr. Angelo Volpe to the meeting and expressed his appreciation for their assistance throughout the year.

Dr. Rhoda next introduced two new staff members that have joined the Commission staff to assist with lottery scholarship analysis. Mr. Chris Brewer, Director of Student Information Systems and Mr. Chris McDavid, Associate Director of Student Information Systems, join Mr. Richard Tucker Associate Director of Assessment and Evaluation in this area of the Commission's responsibilities that are under the direction of Dr. Brian Noland. Also recognized was Dr. Rholanda White-Moore who has served the Commission as one of the Maxine Smith Fellows through the Board of Regents. Dr. Rhoda recognized her for the outstanding assistance she has provided over the last year.

Dr. Rhoda also recognized Ms. Jeri Rampy and Mr. Karl Kruger who redesigned the Commission website, which is now on-line.

Next Dr. Rhoda directed the Commission members' attention to two documents before them. The first was a conflict of interest form that he encouraged each member to complete and return to staff at the end of the meeting. Additionally, he referenced a document entitled "Programs Administered by the Higher Education Commission" that outlines the statutory and other responsibilities of the Commission.

Finally, Dr. Rhoda expressed the resolve of the staff in the further development of the new master plan and revision of the funding formula, which Dr. Noland would address later in the meeting.

Systems' Reports

Tennessee Board of Regents

Dr. Charles Manning, Chancellor of the Tennessee Board of Regents, was recognized. Chancellor Manning began by thanking Mr. Powell and Dr. Rhoda for attending the annual Tennessee Technology Center Awards Program held the previous evening.

Chancellor Manning reviewed with the Commission two processes underway aimed at improving services provided by the TBR and how those services are provided. The first are the academic audits being conducted within the TBR system that are performed for the purpose of ensuring the quality of programs. Secondly, he noted that TBR has begun its strategic planning process which will allow TBR to look at the core elements of what they do and which among competing interests are the most important to follow.

Finally, Chancellor Manning discussed the possibility of significantly increasing tuition at the technology centers over the next few years. This is being necessitated by the fact that traditionally state funds have

accounted for 80 percent of the Centers' funding. When reductions are made in state funding, the technology centers are, therefore, disproportionately affected. He expressed regret, yet indicated that the economics of the situation provided no alternative.

Mr. Powell deviated from the set agenda to enable Dr. Joe Johnson, Interim President of the University of Tennessee to make his presentation upon returning from a legislative meeting.

Academic Affairs

New Academic Programs

Dr. Linda Bradley, Associate Executive Director for Academic Affairs, presented information concerning two items. The first was a new emphasis for an existing center of excellence at the University of Tennessee Martin. The University of Tennessee Board of Trustees had previously endorsed a redesign of the Center of Excellence in Science and Mathematics Education to a Center of Excellence in Experiential Learning in Agricultural Sciences.

Dr. Windley moved to approve the recommendation and to encourage a review of all centers of excellence regarding their relevance. He stated the importance of each center to be as distinctive and functional as possible. The motion was seconded by Ms. Eleanor Yoakum, which was duly adopted.

Dr. Bradley next provided information on a new academic program Regents On-Line Degree Program, Master of Science in Nursing offered through the TBR. She noted that because of the special nature of this new program request, it is being considered outside of the regular cycle on new program approvals. She highlighted the more relevant points of the program, after which Ms. Yoakum made a motion to approve the program as presented. It was seconded by Ms. Winchester and duly adopted by the Commission.

Update on the Tennessee College of Public Health

Dr. Rhoda provided an update on the Tennessee College of Public Health. He reported that based on past discussions it was determined that there was a need for one person to take the lead in working with the various constituencies in seeing this idea come to fruition. It was determined that it would best be handled through the Commission and that Dr. Tom Samuels, recently retired from the University of Kentucky where he was largely responsible for that institutions college of public health, has been selected to lead this project. He advised the Commission that he would keep them, as well as UT and the TBR, apprised of developments in this process.

Postsecondary Education Authorization

<u>Institutional Reauthorization, Temporary Authorization of New Institutions and Approval of New Programs Under the Postsecondary Authorization Act</u>

Dr. Stephanie Bellard, Assistant Executive Director of Postsecondary Authorization presented the recommendation of staff and the Postsecondary Authorization Advisory Committee to grant reauthorization to existing institutions, temporary authorization to new institutions and approval of new programs. These are found in Attachment A to these minutes.

Dr. Bellard first presented the report on postsecondary institutions operating in Tennessee for the period July 1, 2003 through June 30, 2004, and their reauthorization status for the period July 1, 2004 through June 30, 2005. Dr. Bellard reported that were four schools were recommended for conditional authorization, 78 schools were recommended for temporary authorization, 232 schools were recommended for regular authorization, two schools that are pending schools a change of ownership, one seeking voluntary non-renewal of authorization, and five schools closed for a total of 323 institutions.

Dr. Bellard presented the recommendation of staff and the Postsecondary Education Authorization Advisory Committee to grant temporary authorization to the new institutions listed on the agenda. She also recommended approval of the new programs.

Dr. Windley moved to approve the recommendation of the Postsecondary Authorization staff and the Postsecondary Education Authorization Advisory Committee, and Mr. Jones seconded the motion. The motion was duly adopted.

Fiscal Affairs

Governor's Funding Recommendations for FY 2004-2005

Dr. Rhoda presented the Governor's \$1,079,480,000 funding recommendation for higher education. He pointed out that the reduction from the current year's base budget is less than one percent. In making the distribution of that reduction the Commission took total support into consideration to include tuition and other revenue sources. In addition, however, the fee generating entities within higher education will be required to fund a two percent salary increase. A one percent, one-time bonus will be funded with state appropriations. Dr. Rhoda also presented the \$77 million recommendation for capital maintenance and recommended \$141.8 million for capital outlay, which will fund the first 11 projects on the Commission's FY 2004-2005 priority list. He noted that a unique aspect of the recommendation will require a campus match of one-third of the project cost from non-state funding sources, although the details of the program have not been finalized.

<u>Status Report on the Development of a New College and University</u> Funding Formula

Dr. Rhoda reminded the Commission that beginning two years ago with the Plan of Action, the Commission pointed out the need to rethink the way in which higher education requests funding from the state. As a part of that process the Commission consulted with Mr. Dennis Jones, President, National Center for Higher Education Management Systems, to, among other things, propose a new set of institutional peers for each institution. Those recommendations were sent to the respective institutions for their reaction and input. Dr. Rhoda emphasized the point that the peer recommendations are not being endorsed, but are to be used as a vehicle to begin the discussion of the issue. He also indicated that the issue of peers and funding ties into the master planning process, as well as fee policy and financial aid issues, which was the next agenda item.

Policy, Planning and Research

Dr. Brian Noland, Associate Executive Director of Policy, Planning and Research, presented the Commission with a report on the progress toward the development of a master plan for higher education which will encompass both public and independent institutions. He announced that the project will be aided by a grant for the Western Interstate Commission for Higher Education (WICHE). The competitive grant process entitled "Changing Directions" envisioned providing funding to states with plans to coordinate tuition, fee and financial aid policies. Dr. Noland noted that this was a natural fit for Tennessee due to the Commission's previous work on the needs index analysis and the work Dennis Jones has done in Tennessee. He noted these factors help direct the state toward a comprehensive look at educational, economic and demographic conditions to make the best utilization of resources to meet the needs of diverse counties. Dr. Noland concluded by giving the Commission assurance that they would be kept informed of progress.

Minority Teacher Education Grant Awards

Mr. Powell called on Mr. William Arnold, Director of Interagency Grants and Research, to present the recommendations for the Minority Teacher Education Grants. Mr. Arnold noted that the advisory committee and staff recommended approval of the nine projects listed in the agenda item, which are included as Attachment B to these minutes. Discussion centered on the idea that the Commission should look to expand the scope of the program beyond African-Americans in view of the growing Hispanic population.

In a response to an inquiry, Mr. Arnold pointed out that this program targets non-traditional students and those not already in the teaching education programs. Dr. Windley moved to accept the recommendation to fund the nine programs, which was seconded by Mr. Omar Lopez. The motion was duly adopted.

Systems' Reports - Continued

Tennessee Student Assistance Corporation

Dr. Myron Oglesby-Pitts, Deputy Executive Director of the Tennessee Student Assistance Corporation, was in attendance for Mr. Michael Roberts, Executive Director. Mr. Powell formally introduced Dr. Oglesby-Pitts to the Commission and noted that her responsibilities include the implementation of the lottery scholarship program. Dr. Oglesby-Pitts provided the Commission with an update on the program. She indicated that FAFSA applications filed in 2004, which is also the lottery scholarship application, have increased by almost 60 percent over 2003, from 59,017 to 100,664. Dr. Oglesby-Pitts also expressed hope that \$150,000 would be added to the TSAC appropriation to fund the McWherter Scholars Program for 2004.

University of Tennessee

Dr. Joe Johnson, Interim President, University of Tennessee began his report by acknowledging the Commission for the valuable role it plays in the higher education system. He then gave an update on activity within the University of Tennessee System, including the creation of a Vice President for Academic Affairs position for the UT system. He announced that Dr. Robert Levy has been named to fill the position on an interim basis at least until a new president is selected. In a related matter, Dr. Johnson briefed the Commission on the status of the UT presidential search. Dr. Johnson concluded his remarks by outlining several success stories from the various campuses within the UT system.

Legislative Update

Mr. Will Burns, Associate Executive Director for Legal and Regulatory Affairs, provided the Commission with a brief update on the status of legislation impacting higher education and the Commission. His remarks focused mostly on the status of the pending legislation to extend the Commission under the state's sunset review process. He also provided the Commission with an update on various bills related to higher education governance and accountability.

Geier Status Report

Mr. Burns was then called upon to make a report on the status of the *Geier* lawsuit. He reported that since the last meeting, Judge Thomas Wiseman had recently ruled that the \$10 million originally allocated for the law school, had that come to fruition, should be used for the renovation of the downtown Williams Campus of Tennessee State University. The State Building Commission had just recently approved the use of the funds in this manner.

Administrative Items

THEC Policy O5.1 - Conflict of Interest Disclosure Policy for Commission Members, THEC Policy O5.2 - Conflict of Interest Disclosure Policy for Executive Staff

Next Mr. Burns was asked to review with the Commission the proposed changes to the Conflict of Interest policies. Mr. Burns provided an overview on the differences in the current policies and the proposed policies that was before them for approval. He indicated that the change is the result of a number of factors including statutory changes as well as an on-going process to update all Commission policies. Mr. Sims made the motion to adopt the revisions to the two policies and it was seconded by Ms. Yoakum. The motion was duly adopted.

Status of THEC Plan of Action

Dr. Rhoda gave a brief status report on active initiatives of the Commission' plan of action. He reviewed the history of the plan and the status of its various components. He asked Dr. Noland to brief the Commission on a proposal to revise enrollment caps that were in the initial plan of action.

Dr. Noland indicated that enrollment management was placed in the original Plan of Action due to the dire financial condition of the state. Therefore, the Plan of Action included enrollment ranges placed on first time freshmen at the four-year institutions that would be rewarded through the funding formula through FY 2005-2006. Dr. Noland noted that as a result of increased demand caused in part by the lottery scholarship program the original enrollment ranges should be adjusted upward in accordance with the table attached as Attachment C to these minutes.

Ms. Katie Winchester made the motion to approve the recommendation to adjust the enrollment ranges. Mr. Kevin Teets seconded the motion, which was duly adopted.

Chairman's Report - Continued

At the chair's request, Dr. Johnson introduced Dr. Loren Crabtree, Chancellor of the University of Tennessee Knoxville, to make a presentation on the UT/Battelle Partnership. Dr. Crabtree noted that the partnership to operate the Oak Ridge National Laboratory has been in place since 1999, has been a significant stimulus to research at the University, and has also resulted in significant economic development for the state. He noted that the relationship is largely responsible for the more that \$100 million in research grants awarded to the University in FY 2002-2003.

Dr. Crabtree also noted that UT-Battelle partnership has already developed into a world-class scientific computing facility, which will be greatly enhanced if the Department of Energy selects UT-Battelle to build the world's largest non-military computer. This will result in an initial grant of \$25 million. He indicated the Department was expected to make the award in the very near future.

Administrative Items - Continued

Summer Commission Meeting

Dr. Rhoda announced the Commission's Summer Quarterly meeting would be held on July 15, 2004. The time and location will be announced at a later date. He also indicated that there will be a called meeting of the Commission soon after the adjournment of the legislature for the purpose of making tuition and fee recommendations.

There being no further business, Mr. Powell declared the meeting adjourned.

Maintaining effective communication between students and mentors/teachers is a core objective of this program. Students also will be required to attend professional development workshops, utilize the Learning Plus program in the computer lab, and prepare a teaching portfolio.

Funds Recommended \$23,500.00

UNIVERSITY OF MEMPHIS

<u>Project Licensure: Preparing Practicing Non-Licensed Minority Teachers for Licensure and Permanent School Placement</u>

The major goal of this program is to increase the number of African-American teachers in Memphis in collaboration with the Memphis City Schools. A significant component of the program is to better enable the students to pass the required national exams for licensure, which includes participation in intensive clinical experiences prior to teaching. Opportunities are provided for the students to become oriented to the program and to participate in cooperative learning. Project Licensure will give students the skills to positively address the academic needs of children in poverty, demonstrate effective use of strategies for a multicultural population, and demonstrate an understanding of the special needs of urban schools and communities they serve.

Funds Recommended \$25,700.00

UNIVERSITY OF TENNESSEE AT KNOXVILLE

African-American Teacher Intern Project

The goal of this program is to fund African-American students who have completed all prerequisites of college and are entering their fifth year in a teaching internship. The layout of the internship has been developed in accordance with state guidelines and by ongoing collaboration of many school-based professionals, system officials and college representatives. During their internships, the students receive graduate credit for the combination of coursework integrated with teaching and conducting research projects relevant to their teaching.

Funds Recommended \$28,500.00

UNIVERSITY OF TENNESSEE AT MARTIN

SUPPORT #1, MENTOR #1, GRADUATE #1 (S.M.G#1)

S.M.G.#1's goal is to increase the quality, quantity and diversity within a shrinking pool of minority teachers through a two-year mentoring program. This program also increases the students' potential to produce high student achievement in low-performing schools. The program provides at risk minority students access to professionally trained minority faculty, staff and counseling mentors to expand their professional knowledge and skills through the goals of support, mentorship and graduation.

Funds Recommended \$22,400.00

Premise

As a result of systemic budgetary instability, the Tennessee Higher Education Commission issued the *Plan of Action*, a revision to its 2000-05 Master Plan, aimed at promoting a realistic response to the educational and fiscal challenges facing Tennessee. Given the unstable funding environment for higher education and the unlikelihood of additional investments in the foreseeable future, the Commission questioned whether higher education could continue to operate under the modus operandi of "business as usual." The policy initiatives outlined in the *Plan of Action* were designed to encourage Tennessee colleges and universities to strategically position themselves to maintain the highest level of academic integrity and quality. One of the central components of this strategic repositioning was the adoption of an enrollment management plan that would balance the need for increased access to higher education while also ensuring greater efficiencies given the funding environment for public post-secondary education.

In the original version of the *Plan of Action* the Commission called for the implementation of an enrollment management plan that would serve to balance the tension between access and quality. Given the probability of continued limitations in state support, coupled with projected enrollment growth that would further strain institutions, the Commission implemented a state-wide enrollment management policy that created enrollment ranges for first-time freshmen in the university sector. Rather than limit overall enrollment, this policy provides opportunities for the state to responsibly manage enrollment. For example, this policy is designed to encourage institutions to increase student persistence and creatively utilize distance education technology. The Commission's enrollment management plan also calls for a greater emphasis on increasing successful transfer and articulation between community colleges and universities and encourages the broader utilization of the available capacity of the community colleges.

Policy Revision

As a result of the implementation of the Tennessee Education Lottery Scholarship program, the staff recommends a revision to the enrollment management policy outlined in the *Plan of Action*. While the staff remains committed to the original goals and intent of this policy, accommodations should be made to support the legislative intent of the scholarship program, improving access to post-secondary education and retaining more of Tennessee's best and brightest students. Preliminary research indicates that a significant number of high school graduates will qualify for the awards; therefore, the scholarship program will inevitably lead to increased pressure for access to post-secondary education. In recognition of the tension between this reality and the enrollment components of the *Plan of Action*, the staff recommends that the original enrollment ranges be adjusted to provide latitude for institutions to accommodate lottery-related enrollment growth. Given the fluid nature of lottery driven enrollment, both the state and institutions require an increased degree of flexibility to ensure that the statutory intent of the program is achieved.

The proposed revision is based upon the upper bound of the three year enrollment range contained within the *Plan of Action*. The staff recommends that these ranges provide a maximum ceiling for institutional enrollments for the 2004-05 and 2005-06 academic years. If the number of **first-time freshmen** exceeds the ceilings listed below, the additional students and their corresponding FTEs will not be included in the Commission's funding formula calculations. However, institutions will be able to retain any tuition and fee revenue that is generated from such enrollments.

This policy adjustment will provide flexibility for institutions to accommodate projected increases in enrollment that may occur as a result of the implementation of the HOPE lottery scholarship program. As a result of this policy adjustment, institutions will be able to accommodate an additional 892 FTE over the current enrollment ceiling, or an additional 2,833 FTE over state-wide fall 2003 enrollment levels.

At the conclusion of the 2005-06 academic year, the Commission staff will revisit these ranges and other enrollment management issues. In the interim, the Commission staff will work cooperatively with the governing boards to conduct a detailed review of admissions policies to ensure that they adequately reflect institutional mission, fiscal reality, and the goals of the 2005-10 statewide Master Plan for higher education in Tennessee.

This special called meeting was initiated pursuant to responsibilities of the Commission outlined in Tennessee Code Annotated §49-7-202(c)(3)(C), to make a recommendation on in-state maintenance fees and out-of-state tuition for the 2004-2005 fiscal year. A quorum of members physically present at the meeting could not be achieved; however, additional members participating electronically made a quorum.

It was necessary to have the meeting at this time in order to fulfill statutory obligations. Because a recommendation on tuition and fees has traditionally been determined based on final appropriations for higher education, but must be made prior to the summer meetings of the two governing boards, there is a limited opportunity for setting a meeting for this purpose.

The date of this meeting was determined based on the belief that it offered the best chance of having a quorum present either physically at the meeting site or a combination present and others participating electronically prior to the meetings of the Tennessee Board of Regents and University of Tennessee Board of Trustees at which changes in fees would be approved.

The meeting was called to order by Chairman Jim Powell and he welcomed all to the meeting.

FY 2004-2005 Maintenance Fees and Out-of-State Tuition

Mr. Powell recognized Mr. Jim Vaden, Associate Executive Director for Fiscal Affairs, to present this agenda item. Mr. Vaden announced that the sole purpose of this meeting was to take action on the Commission staff's recommendation to increase in-state maintenance fees and out-of-

state tuition. He stated that the Commission staff was recommending a 7 percent across-the-board increase in the in-state maintenance fees and out-of-state tuition at the universities, to include the professional schools, and community colleges. He further stated that the staff was recommending a minimum increase of 7 percent for the technology centers. A copy of the recommendation is included as Attachment A.

For the purposes of discussion, Mr. Powell asked for a motion on the recommendation. Ms. Debby Koch made the motion and it was seconded by Mr. Dale Sims.

Mr. Vaden provided an overview of the basis for the recommendation. He stated that the restoration of the \$9.2 million reduction to the 2004-2005 higher education appropriation enabled staff to consider a 7 percent increase, instead of an increase closer to 9 percent that had been considered early in the process. An increase of 7 percent is necessary to cover escalation in fixed costs and to fund 2 percent of the 3 percent salary increase.

In addressing the need for a minimum of 7 percent for the technology centers, Mr. Vaden stated that those institutions are more reliant on state appropriations and therefore are more adversely impacted by reduced or stagnant appropriations.

Mr. Vaden said that in future years the Commission staff was considering making its tuition and fee recommendation as part of its appropriation request for higher education in a manner more reflective of the linkage that exists between the two funding sources, as well as the effect each has on student financial aid. He also stated that the staff would be reviewing the prospects of providing a greater percentage of new state appropriations to the community colleges and technology centers.

In response to questions, Mr. Vaden indicated that when state appropriations and revenue are combined, the 2004-2005 funding formula recommendation will be funded at 94 percent with a 7 percent increase as compared to 96 percent for the 2003-2004 academic year.

Dr. Charles Manning, Chancellor, Tennessee Board of Regents expressed his appreciation of the recommendation and stated that the TBR would follow through with fee increases consistent with this recommendation.

Mr. Dale Sims noted that even with the increases provided by the recommendation, there will be no significant change in the relative position of the state institutions with their respective peers. He also noted that the General Assembly will appreciate the action in view of its efforts to restore higher education budget reductions.

There being no further discussion, Mr. Powell called for a vote on the motion that was duly adopted by the following roll call vote:
