MINUTES

TENNESSEE HIGHER EDUCATION COMMISSION Winter Quarterly Meeting November 18, 2004, 1:00 p.m. CST

Adoption of Agenda

Mr. Powell called for a motion to adopt the agenda. The motion was made by Ms. Katie Winchester and seconded by Dr. Brad Windley. The motion was duly adopted.

Approval of Minutes, July 15, 2004 Meeting

Mr. Powell asked for a motion to approve the minutes of the July 15, 2004, Commission meeting. Ms. Winchester made the motion which was seconded by Ms. Debby Koch. The motion was duly adopted.

Chairman's Report

Mr. Powell began his report by recognizing Mr. Russ Deaton, Director of Fiscal Analysis, who provided the Commission with a report on the status of the private giving study that the General Assembly directed the Commission to perform. Mr. Deaton reviewed with the Commission the methodology being used to acquire and analyze the information and noted the assistance of an advisory committee composed of development officers at public institutions and others, including Commission members Ms. Katie Winchester, Mr. Jack Murrah and General Wendell Gilbert. He stated that the report will be completed soon and delivered to the Governor and Legislature by the December 15, 2004 deadline.

Executive Director's Report

Dr. Richard Rhoda, Executive Director, began his report by welcoming all to the meeting. Among others, he specifically recognized Representative John Hood. He next introduced two new Commission members, Ms.

Dawn Blackwell, a student member who is a junior at East Tennessee State University, and Dr. Gary Nixon in his capacity as the new Executive Director of the State Board of Education.

Dr. Rhoda then introduced staff members who were hired since the last meeting of the Commission. They were Mr. Jason Cavender, Director of Business and Finance, Ms. Michelle McEwen, Accounting Technician I, and Ms. Shanta Wilson, Accounting and Personnel Officer. Dr. Rhoda also noted that Mr. Eric Ness, Associate Executive Director for Policy, Planning, and Research, has returned to the Commission after a two month internship in Vanderbilt University's Washington D.C. office.

Dr. Rhoda recognized Dr. Marva Lucas who serves as the Interim Director of the Developmental Studies Program at Middle Tennessee State University. Dr. Lucas will work with the Commission as a Maxine Smith Fellow through the Tennessee Board of Regents.

Dr. Rhoda then reported that the Commission staff had secured two grants from the Lumina Foundation. The College Goal Sunday grant of \$7,500 supports programs to educate college-bound students and their parents concerning the application process for federal financial aid programs. The Foundation also awarded \$403,000 for a two-year period to replicate the Educational Needs Index on a national scale; Austin Peay State University and the National Center for Higher Education Management Systems are partners in the project. Dr. Rhoda recognized Dr. Brian Noland as the lead staff member in securing both grants.

Systems' Reports

Tennessee Board of Regents

Dr. Paula Short, Vice Chancellor for Academic Affairs, for the Tennessee Board of Regents was recognized by Mr. Powell to present the TBR report. Dr. Short recognized Dr. Harriet Insignares, Professor in the Department of Communications at Tennessee State University, who will serve as a Maxine Smith Fellow in the TBR academic affairs office.

Dr. Short provided an overview of two TBR projects. The first was the *Setting New Directions* strategic plan process for 2005-2010. Commenting of the fact that the TBR timeframe coincides with the Commission's master planning timeframe, she expressed appreciation to Dr. Rhoda for his involvement in the process.

Next Dr. Short provided an overview of the work being done on the academic audit pilot that is proceeding under the direction of Dr. William Massey, President Emeritus of Stanford University.

University of Tennessee

Dr. Jack Britt, University of Tennessee Executive Vice President, was recognized by Mr. Powell to give the report on behalf of the university. Dr. Britt began by expressing regret that Dr. John Petersen, President of the University of Tennessee, could not attend the meeting but was at Duke University attending a meeting of the UT/Battelle Board of Directors. Dr. Britt provided an overview of Dr. Petersen's recent State of the University speech on his first 120 days in office.

Among the items highlighted by Dr. Britt were the various personnel searches that were underway. These include searches for vice presidents of Public and Government Relations, Research, Agriculture, and Finance, as well as chancellors for the Chattanooga and Memphis campuses.

He concluded by emphasizing the university's support for higher education to pursue a bond issue that will fund the capital outlay priorities that have grown over the years of little or no funding by the Legislature.

<u>Tennessee Student Assistance Corporation</u>

Dr. Rhoda presented this report in his role as Interim Executive Director. He noted that the transition is going well due in large part to the THEC and TSAC staffs working together. He specifically noted Ms. Jeri Fields-Rampy, Assistant Director or Policy, Planning, and Research, who has taken on additional responsibilities with marketing/outreach for the lottery scholarship program, and Mr. Phil Purvis, Fiscal Officer, who is working with TSAC personnel on budget matters.

Academic Affairs

New Academic Programs

Dr. Linda Bradley, Associate Executive Director for Academic Affairs, presented information concerning two new academic programs:

- Middle Tennessee State University, Masters of Science in Professional Science with concentrations in Biostatistics, Biotechnology and Health Care Informatics: and
- Austin Peay State University, Bachelor of Science in Criminal Justice with a concentration in Homeland Security.

Dr. Bradley reviewed the documentation in support of these new programs and highlighted the more relevant points. Mr. Ransom Jones made a motion to approve the programs as presented. Dr. Brad Windley seconded the motion, which was duly adopted.

Status of the Tennessee College of Public Health

Mr. Tom Samuel, Associate Executive Director of Health Services, provided the Commission with an update on establishing accredited Tennessee Colleges of Public Health. Mr. Samuel noted the excellent

cooperation among the various institutions and the Tennessee Department of Health in this effort.

He announced that East Tennessee State University would establish a free-standing college of public health in view of the fact that it already has established programs in four of the five areas that would compose the college. Mr. Samuel also noted that Tennessee State University is making plans to develop a public health program which would offer degrees in this area. In the same vein, the University of Tennessee Knoxville will continue to develop its current program in public health.

Mr. Samuel reported that the University of Memphis and the University of Tennessee Health Sciences Center are making plans for a collaborative project that would be led by the University of Memphis. He noted the high degree of cooperation between the two systems to accomplish this objective. Mr. Powell called on Dr. Shirley C. Raines, President of the University of Memphis, who noted that the plan to form a joint college of public health is a good plan and expressed her desire to continue to work collaboratively to enhance the delivery of health care in Tennessee through the research that this college will perform.

Postsecondary Education Authorization

<u>Temporary Authorization of New Institutions, Approval of New Programs</u> <u>Under the Postsecondary Authorization Act</u>

Dr. Stephanie Bellard, Assistant Executive Director of Postsecondary School Authorization, presented the recommendation of the staff and the Postsecondary Authorization Advisory Committee to grant temporary authorization to new institutions and approval of new programs. These are found in Attachment A to these minutes.

Ms. Winchester moved to approve the recommendations. The motion was seconded by Ms. Eleanor Yoakum and duly adopted by the Commission.

Dr. Rhoda commended Dr. Bellard and her staff for their excellent work in compiling information for a legislative study authorized during the last session. The study will focus on institutions offering allied health or massage therapy programs and the adequacy of the education each is providing and how the fees to enroll in the program compare to anticipated earnings upon graduation.

Fiscal Affairs

2005-2006 Appropriations Recommendations: Operating, Capital Outlay, and Capital Maintenance

Mr. Powell next recognized Mr. Jim Vaden, Associate Executive Director of Fiscal Affairs to provide an overview of the appropriations recommendation for FY 2005-2006, which is Attachment B to these minutes. Mr. Vaden noted that the recommendation reflected no growth over the current fiscal year base appropriation. He also noted that this recommendation was not to be confused with the actual fiscal need of higher education, but reflects the reality of no new state funding. Mr. Vaden then recognized Mr. Deaton who provided more detail on alternative recommendations in the event additional funding was made available for higher education. Mr. Deaton also provided additional information relative to the capital outlay and maintenance recommendations.

In response to an inquiry from Mr. John Morgan, there was discussion on the appropriateness of a recommendation that does not address true fiscal need. The general consensus was that, while significant increases in funding are needed, the distribution recommendation was reasonable given the current financial condition of the state. Following the discussion Dr. Windley moved to adopt the recommendations and grant Dr. Rhoda authority to make technical revisions and corrections. The motion was seconded by Mr. Jack Murrah and then duly adopted with Mr. Morgan abstaining.

Policy, Planning, and Research

Fall 2004 Enrollment and Lottery Scholarship Update

Dr. Brian Noland, Associate Executive Director for Policy, Planning, and Research, was recognized to present enrollment data for the fall 2004 semester. He noted that both headcount and full time equivalent enrollment increased over 2003 enrollment counts. Among the trends he discussed was the African-American enrollment, which has increased to a headcount of 38,026 representing an increase in excess of 32 percent over the 23,855 African-American enrollment in 1994. He also noted that African-American students comprise 19 percent of the total headcount enrollment in contrast to just 14 percent of the total headcount in 1991 when there were 25,869 African-American students.

Dr. Noland also provided an update on students receiving a Tennessee Lottery Education Lottery Scholarship. He noted that almost 30,000 freshmen and sophomores received the Tennessee Hope scholarship with 2,077 of these students also receiving the General Assembly Merit scholarship and another 7,820 of them also receiving the need based supplement. Dr. Noland also noted that 91 students received the

ACCESS scholarship. The total value of the awarded scholarships is approximately \$45 million.

Dr. Gary Nixon reported on the actions taken by the State Board of Education to promoter the lottery scholarship.

Master Plan Update

Dr. Noland gave the Commission an update on the progress to implement the 2005-2010 Master Plan. He noted that the funding formula and performance funding are all being revised to reflect the goals and objectives in the master plan. Dr. Noland stated that the completed plan will be submitted to the Commission for approval at the Spring 2005 meeting

Improving Teacher Quality Grant Program Awards, 2004-2005

Mr. Powell recognized Mr. William Arnold, Director of Academic Programs and Interagency Grants, to make a report on Improving Teacher Quality Grants for 2004-2005. Mr. Arnold noted that of the 43 proposals submitted for these federal grant funds, the advisory committee identified 19 for funding. The projects recommended for funding are included in Attachment C to these minutes. Dr. Windley noted that although he was unable to attend the advisory committee as in past years, he was able to review the proposals and supports the recommendations being made and thus moved for their approval. Mr. Jones seconded the motion, which was duly adopted.

Geier Status Report

Mr. Powell called on Mr. Will Burns, Associate Executive Director of Legal and Regulatory Affairs to make a report on the status of the *Geier* lawsuit. He reported that there were three items of note that have transpired since the last meeting of the Commission. He first noted the symposium hosted by the Tennessee Board of Regents in recognition of the 50th anniversary of the decision in *Brown vs. Board of Education* overturning the "separate but equal" doctrine that was the basis for segregation of public schools. He congratulated Dr. Paula Short and Ms. Wendy Thompson for their work in providing the program.

Mr. Burns advised the Commission of a change in the administration of the Masters of Science in Nursing offered at all TBR universities through the Regents On-Line Degree Program. He noted one of the plaintiff-interveners in the *Geier* lawsuit expressed concern that it would adversely affect the same program offered on the TSU campus. As a result, to ensure compliance with *Geier*, the court monitor brokered an agreement that would provide that students applying to the on-line program from counties in Middle Tennessee will be randomly assigned TSU, MTSU or APSU as their home institution.

Finally, Mr. Burns noted that TBR is beginning to review how to pursue desegregation activities when the state is no longer under the provisions of the *Geier* settlement. He advised the Commission of the staff's involvement in that process and noted that Mr. Arnold would attend a meeting hosted by TBR the following week. This meeting is to hear from Mr. Jonathan Alger, Associate General Counsel for the University of Michigan, addressing how that institution is proceeding in light of the U.S. Supreme Court decisions relative to racial preferences in its admissions policies.

Administrative Items

Dr. Rhoda directed the Commission to information under agenda item VI., which listed the Commission's 2005 meeting dates. He specifically announced that the Commission was next scheduled to meet on Thursday, January 27, 2005, which would include a joint meeting with the State Board of Education, at a time and location to be determined.

There being no further business, Mr. Powell declared the meeting adjourned.
