SUBJECT: Update on the Performance Funding Program

ACTION RECOMMENDED: Information

BACKGROUND INFORMATION: At the April 2005 meeting, the Commission approved the Performance Funding standards for the 2005-10 cycle. Since 1979, the performance funding program has addressed public policy concerns regarding the need to strengthen Tennessee's public higher education system and make institutions more competitive in the region. The performance funding program is designed to stimulate institutional improvement and student learning as institutions carry out their respective missions. The third year (2007-08) of the cycle has ended with institutional reporting on their performance in August 2008. Performance from academic year 2007-08 will be used in the FY 2009-10 funding formula allocation.

The performance funding program is an incentive opportunity for institutions to earn resources above and beyond formula-based appropriations. Institutions can earn up to 5.45 percent of their state operating appropriations. The program is based upon a point scale from 0 to 100. These performance funding dollars are made available to the college's general funds to be used for institutional priorities at the discretion of the institution. Table 1 provides the performance funding points and dollars earned for the first two years of the 2005-10 cycle. These point allocations were utilized in the FY 2007-08 and FY 2008-09 budget cycles.

As in previous cycles, the program is focused on indicators related to student, program and institutional indicators. Overall, the 2005-10 performance funding program measures 17 indicators. These indicators are broadly defined within the following five standards:

- 1) Student Learning Environment and Outcomes
- 2) Student Satisfaction
- 3) Student Persistence
- 4) State Master Plan Priorities
- 5) Assessment Outcomes

New features of the 2005-10 performance funding cycle include:

- Serves as the assessment piece for our state-wide master plan, Creating Partnerships for a Better Tennessee;
- Capitalizes on availability of national benchmarking tools (e.g., student engagement surveys, instructional cost studies and retention/persistence rates);

- Recognizes the regional accreditation process in using performance funding data and other assessment tools for student learning and institutional improvement;
- Encourages institutional focus on outcomes rather than processes;
- Uses institutional formula peer sets to benchmark retention and persistence rates;
- Continues to stress transfer student success; and
- Continues to emphasize employer feedback.

The Performance Funding Program has been a hallmark of assessment and planning in which Tennessee has engaged in for close to three decades. What are some of the benefits of Tennessee's long history of assessment and planning? One major benefit has been the establishment of an assessment infrastructure on campuses. This has rewarded institutions in more ways than simply getting performance funding dollars. Another benefit is that each institution determines where best to place performance funding dollars to improve the quality of their institution.

The Performance Funding program is redesigned periodically. This keeps it responsive to changing environments, but provides for meaningful evaluations of student performance, academic programs and other institutional indicators over time. Beginning in January 2009, the Commission staff along with staff from the Tennessee Board of Regent and the University of Tennessee system will begin the collaborative process of planning for the 2010-2015 performance funding cycle. At the April 2010 Commission meeting, the new standards will be presented for your approval.
