The division will hold a public hearing to seek comment concerning an application for a state water quality permit. The permit is required for alterations to numerous tributaries including Locke Branch, Boston Branch, Moore's Branch, Garrison Creek, South Garrison Branch, Burns Branch, Leipers Creek, Robinson Branch, Sycamore Creek, and West Prong Murfrees Fork. The project is located on SR840 from East of Pinewood Rd to West of Columbia Pike, Williamson County. The proposed alterations include the modification of 10,816 ft. of streams and 0.173 acre of wetlands.

In anticipation of public interest in this project, the applicant has volunteered to hold a public hearing to discuss water quality concerns. Persons wishing to comment on or object to the application proposal are invited to deliver oral or written comment at the public hearing. The hearing officer will limit all testimony to relevant water quality issues and may limit testimony in the interest of time. However, all persons desiring to speak will be given an opportunity to do so. Written testimony will be accepted for 10 days following the hearing and will be considered part of the official record. The public is also invited to submit comments in writing to the division at the address printed below. The comments must be received by September 5, 2008. After considering all public comments, the division will publish a final permit decision and a notice of the division's determinations.
