Code Ann. §56-55-104(d), if a registrant fails to properly renew its registration by July 1 of each year, the Commissioner shall give the registrant written notice of the failure. The registrant shall then have thirty (30) days from the date of its receipt of such notice to complete the renewal of the registration before the registration is revoked. Such revocation does not require any additional notice or a hearing. Any registrant with a revoked registration must reapply for a new registration.**

The Warrantor must attach the following to this registration form:

- A true and correct copy of the warranty reimbursement insurance policy that complies with Tenn. Code Ann. § 56-55-106;
- Two (2) sample copies of each warranty the warrantor proposes to use in this state.
- Attach renewal fee in the amount of \$515.00 made payable to TN Department of Commerce & Insurance.

Pursuant to Tenn. Code Ann. §56-55-112 any warrantor doing business in this state in accordance with this chapter shall be deemed to have appointed the commissioner its true and lawful attorney upon whom may be served all lawful process in any action or proceeding against it.
