Episodes of Care updates

- Wave 5 episode of care TAGs continue to meet. The last meeting will occur in mid-May. The seven episodes included in wave 5 are breast biopsy, mastectomy and medical oncology; tonsillectomy and otitis media; anxiety and chronic depression.
- These episodes will begin reporting in May 2017.
- Waves 3 and 4 preview reports will begin in May 2016 for 12 episodes: GI hemorrhage, EGD, respiratory infection, pneumonia, UTI-inpatient/outpatient, ADHD, ODD, CHF, CABG, valve repair and replacement, and bariatric surgery.

CMS Announcement on Comprehensive Primary Care Plus (CPC+)

- On Monday April 11, 2016, the Centers for Medicare and Medicaid Services (CMS) announced Comprehensive Primary Care Plus (CPC+), an advanced primary care model.
- CPC+ is a regionally-based, multi-payer care delivery and alternative payment model that rewards value and quality through an innovative payment structure to support comprehensive primary care. The model will offer two tracks with incrementally advanced care delivery requirements and payment options to meet the diverse needs of primary care practices.
- CMS is soliciting payer proposals to partner with Medicare in CPC+ from April 15 - June 1, 2016.

CMS Announcement on Comprehensive Primary Care Plus (CPC+)

- CMS will select up to 20 CPC+ regions and solicit applications from providers within those regions from July 15 – September 1, 2016.
- We are evaluating the details of CPC+ as they continue to be released to determine how CPC+ may enhance the Tennessee Health Care Innovation Initiative.
