

Mayor Bill Orange requested a hike in pay to approximately \$92,000 a year last month.

During the Commission Budget Committee meeting on Tuesday, Budget Director Tara Patterson told the committee that Sheriff John Holder and Highway Superintendent Jerry Carney have requested pay hikes amending their original budget requests for the fiscal year that begins July 1.

Sheriff Holder's request is based on an additional \$15,000 per year due to his responsibility for overseeing the jail and workhouse of the county. If approved, the Sheriff's pay would rise from \$66,960 to \$81,960.

Roads Director Carney has requested his pay to keep pace with the county executive and state statute that declares the County Mayor must make a minimum of 5% above the offices of

Carney's pay would rise to approximately \$87,400.

Patterson said Court Clerk Julie Womack had requested a hike in pay with an additional ten percent for her office overseeing both the General Sessions and Juvenile Courts. The hike, if approved, would take the Womack's pay to \$66,959. During Tuesday's meeting discussion centered on the possible need to go across the board on all elected officials and Chancery Court Clerk Pam Jenkins who is appointed by Circuit Court Judges.

Mayor Orange requested that his pay be increased by approximately \$42,000 a year to match what is currently paid to Cheatham County Director of Schools. Mayor Orange in a recent radio interview on WQSV said the raise was needed. "When I started this job (County Executive) nine years ago,

- 1. Ordinance 07-01** AN ORDINANCE OF THE TOWN OF PLEASANT VIEW, TENNESSEE, ADOPTING A BUDGET FOR THE FISCAL YEAR JULY 1, 2007 THROUGH JUNE 30, 2008.
- 2. Ordinance 07-02** AN ORDINANCE AMENDING TITLE 1 OF THE TOWN OF PLEASANT VIEW MUNICIPAL CODE AND TO ADOPT A CODE OF ETHICS FOR THE TOWN'S OFFICERS AND EMPLOYEES.
- 3. MORE PARTICULARLY, AN ORDINANCE TO REZONE MAP 10, PARCEL 061.06 OF THE CHEATHAM COUNTY TAX MAP, MORE PARTICULARLY KNOWN 2349 HIGHWAY 49E FROM R2 TO C1.
