If the owner or operator spray applies coatings, then the owner or operator must complete the required training and certify himself or herself as well as the other painters at the facility. This example training certification format is not required to be used under the rule. The owner or operator may use an alternate certification format provided that all the rule requirements have been satisfied.
