Per the specifications, Section 5: Participating Authorized Distributor(s) shall offer installation at a rate not to exceed the hourly rate established via Attachment A: Evaluation Model, with miscellaneous supply (cable, wires, connectors, cable ties, etc.) charge not to exceed the per vehicle rate established in Attachment A: Evaluation Model.

1 1 1 2	Specificat ions - Section 5 last paragrap h Specificat ions – Section 6	It states Cables and Wiring, can we include wiring harnesses that are used to ensure a more robust installation? Should this be another line item to quote? Catalog: New product offerings that meet the intent of this contract may only be added on January 1 and July 1 of each year. The Manufacturer must communicate the new models and their pricing to the state by the 1 st of January and July of each year. Do I understand this correctly?	 Wiring harnesses would be included in the etc. A wiring harness does not need to be another line item to quote as they are not necessary for every installation of emergency equipment. Yes, the Manufacturer can update their catalog on 1 January and/or 1 July of each year.
1 3	Specificat ions – Section 6	Escalator Clause: If the manufacturer has issued a new commercially published price list to the market with price changes (increased or decreased) then the authorized distributor can pass along the price changes effective upon the effective date of the new price list. It does not state that the manufacturer/authorized distributor must have approval by the state prior to passing along any price changes. Do we understand this clause correctly?	The Escalator Clause pertains to catalogs only. The updated catalogs still need to be passed to the State for upload. Catalog updates per the Specifications are to be updated on semi-annually (1 January and/or 1 July) of each year.

Edits to ITB bid factor: Respondent shall provide a list of distributors who can provide goods and installation with the State.

Added the word installation into the sentence in ITB details and Specifications, Section 4: that Respondents shall provide a list of their Authorized Distributor(s) who can distribute and provide installation throughout the State of Tennessee.
