The course will be closed Monday-Thursday starting May 1, 2024, for renovation of the playing surfaces on fairways and green surrounds. During May 1 through June 30, the front nine will be closed to all play while the back nine will be open on Friday, Saturday, and Sunday. During July 1 through August 29, the back nine will be closed to all play with the front nine open for play Friday, Saturday, and Sunday. To eliminate the cost of remobilization, the Contractor will be permitted to work on the back nine Monday through Thursday starting on May 1. The Contractor will be required to leave the worksite on the back nine in a safe and presentable nature during Friday through Sunday due to golfers being present. Course officials will work with the Contractor to facilitate the safe and quick completion of the project.
