# Domestic Violence -- Overview

## What is domestic violence?

Domestic violence is violence committed by someone in the victim's domestic circle. This includes partners and ex-partners, immediate family members, other relatives and family friends. It can involve physical violence, sexual violence, threats, and economic, emotional and/or psychological abuse. When domestic violence occurs within a romantic relationship it is sometimes referred to as intimate partner violence (IPV). [1,2]

## What are the consequences of domestic violence?

Chronic exposure to domestic violence—and the stress and fear resulting from this exposure—can cause not only immediate physical injury, but may also impact the victims' mental health as the mind attempts to process trauma or protect the body. Domestic violence affects one's thoughts, feelings and behaviors. Increased anxiety, post-traumatic stress disorder and depression symptoms are commonly observed among survivors of domestic violence. ## Domestic Violence in the United States

Anyone can be a victim of domestic violence regardless of age, race, sex, sexual orientation or gender identity. [1,2]

- Every 60 seconds, nearly 20 people in the U.S. are physically abused by an intimate partner. [2]
- One out of every 4 women and one out of every 9 men has been the victim of IPV in her/his lifetime. [2]
- More than 1 out of every 2 transgender persons have experienced some form of IPV. [4]

## Underreporting of Domestic Violence

- Only 56% of non-fatal domestic violence victimizations are reported or otherwise known to the police. [5]
- The most common reason cited by victims for not reporting domestic violence to police is the personal nature of the incident. [5]

## What is the Tennessee Department of Health doing to address domestic violence?

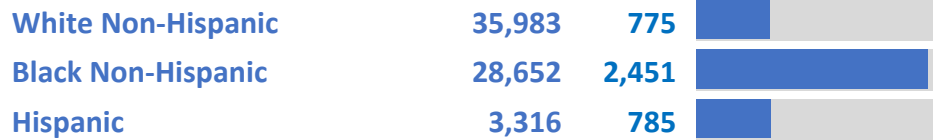
The Department's [Rape Prevention Education](#) (RPE) Program works with several community partners to bring awareness to domestic violence and promote prevention efforts. The RPE Program partners with the [Tennessee Coalition to End Domestic Violence](#), who administer the Domestic Violence Prevention Enhancement and Leadership through Alliances Grant in Tennessee, to work on initiatives to prevent domestic violence. Additionally, the RPE Program partners with the Tennessee Family Planning and Breast and Cervical Screening Programs to increase screening of clients and awareness of domestic violence through campaigns such as “Wear a Little Purple with Your Pink.”

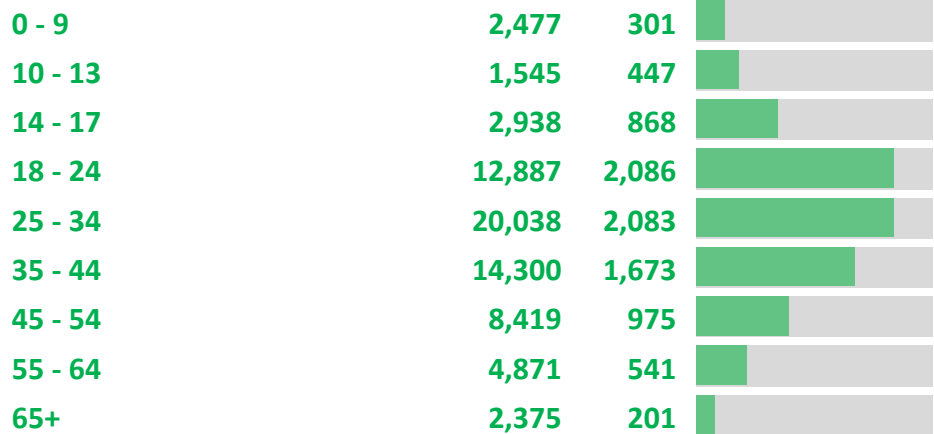

## Race/Ethnicity



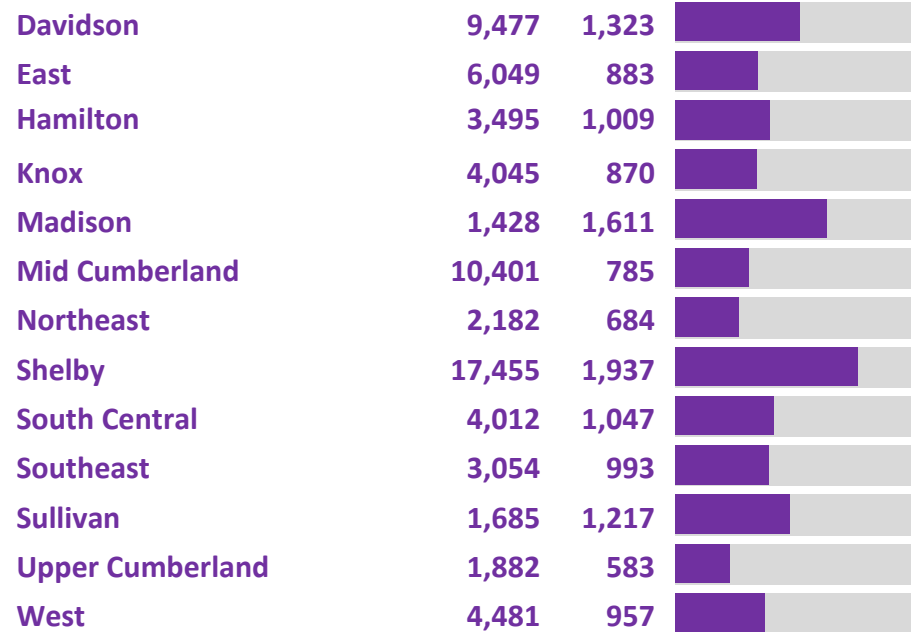

## Sex



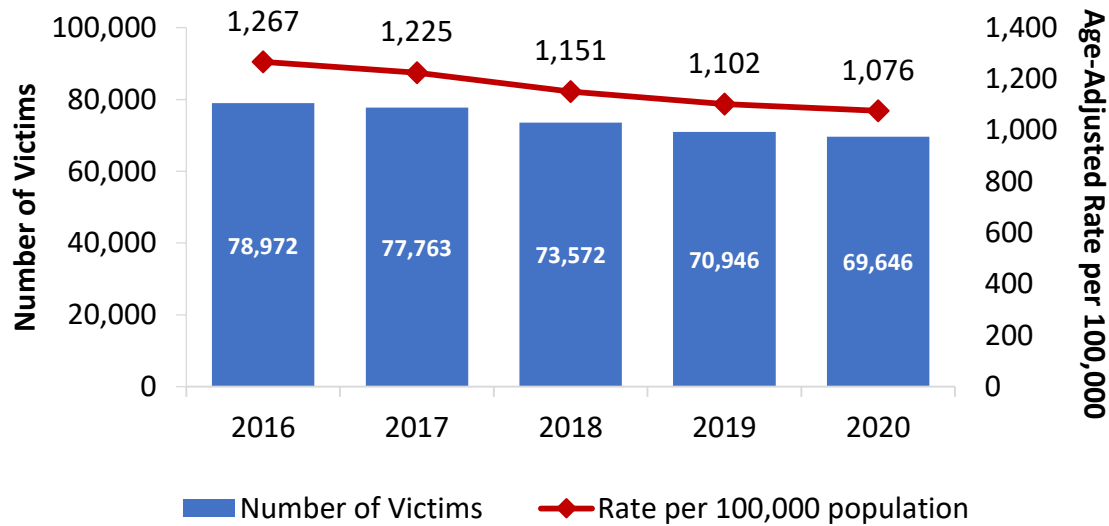

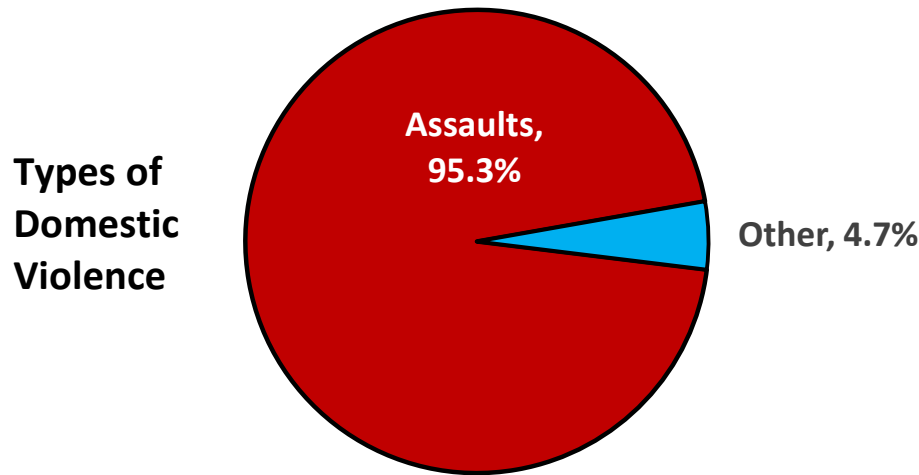

# Domestic Violence Victims *cont.*

## 5-Year Trend in Domestic Violence Victims



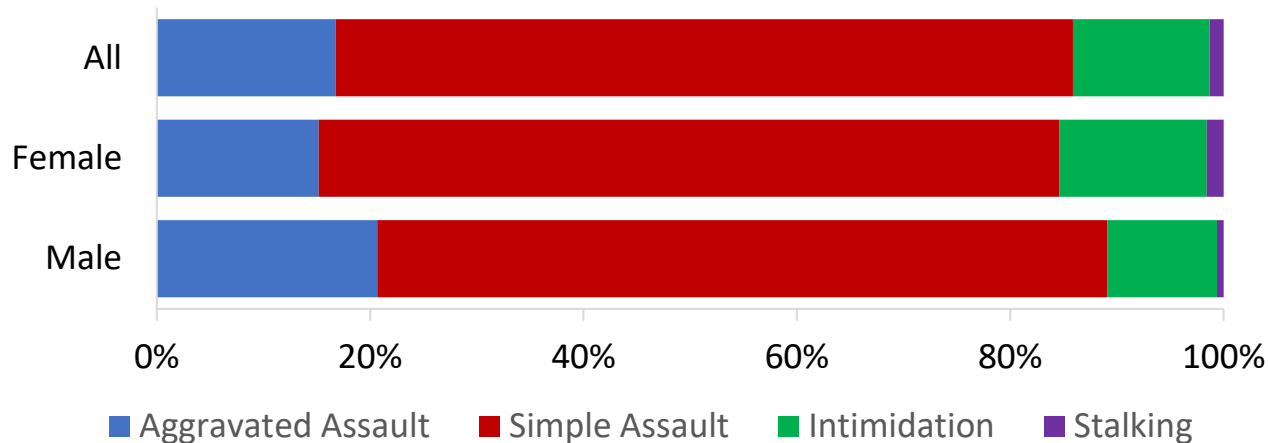
- In 2020, there were 69,646 domestic violence victims reported to Tennessee law enforcement agencies. This represented about 1,076 victims for every 100,000 persons in the population.
- There was a statistically significant decrease in the number and rate of domestic violence victims between 2016 and 2020. The rate of decline slowed slightly from 2019 to 2020.\*
- Eighteen to thirty four-year olds had the highest rate of domestic violence victimization compared to other age groups.
- Black non-Hispanics were more likely than white non-Hispanics or Hispanics to be victims of domestic violence.
- Among Health Department regions, the rate of domestic violence victimization ranged from 583 in Upper Cumberland to 1,937 in Shelby.
- The majority of domestic violence offenses were assaults (95%) compared to other types of offenses (5%).



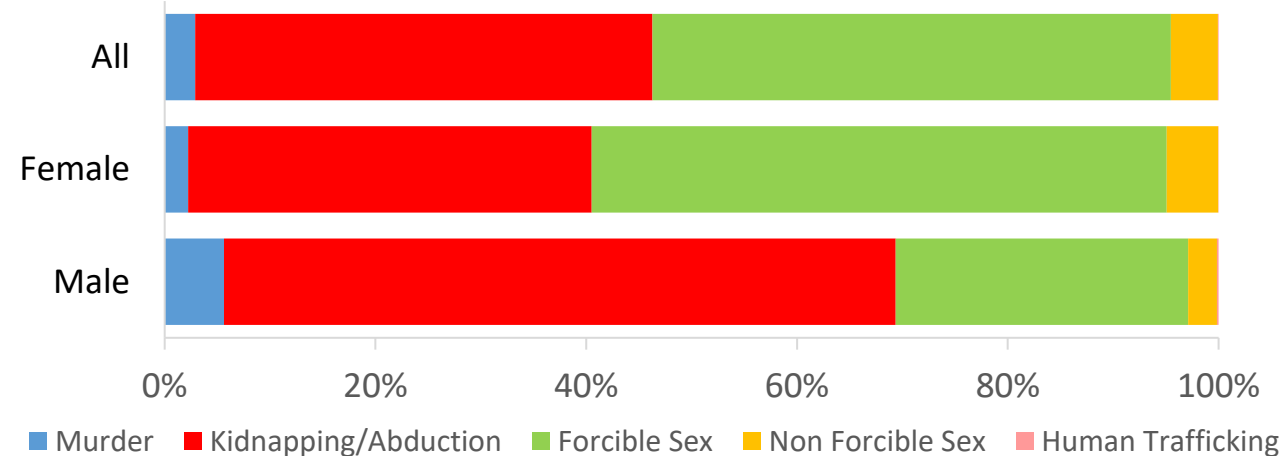

### Distribution of Other Domestic Violence Offense Types by Sex



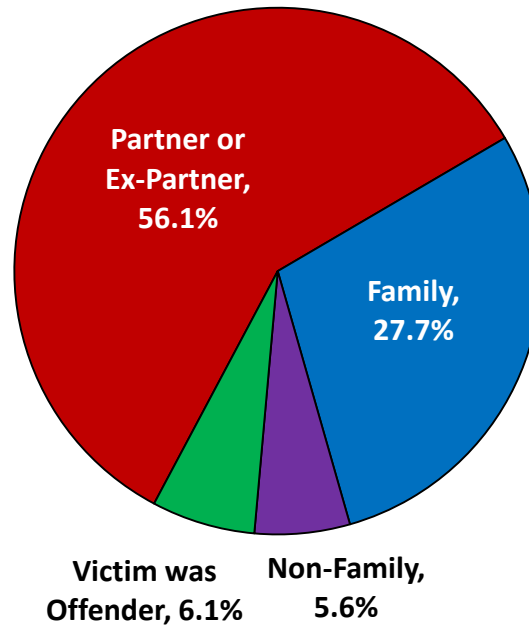
- Simple assault involves physical attacks where the offender does not display a weapon and the victim does not suffer a serious injury. This was the most common type of domestic violence assault against both men and women.
- Aggravated assault involves physical attacks where the offender uses or displays a weapon or the victim suffers severe injury (e.g., broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness). This was more common among male victims compared to females. In contrast, intimidation and stalking were more common among female victims.
- Forcible sex was the most common type of non-assault domestic violence offense against women, while kidnapping/ abduction was the most common type against men.
- Domestically related murder was more common among male victims than among female victims.
- There were only two reported victims of domestically related human trafficking in 2020 -- one male and one female.

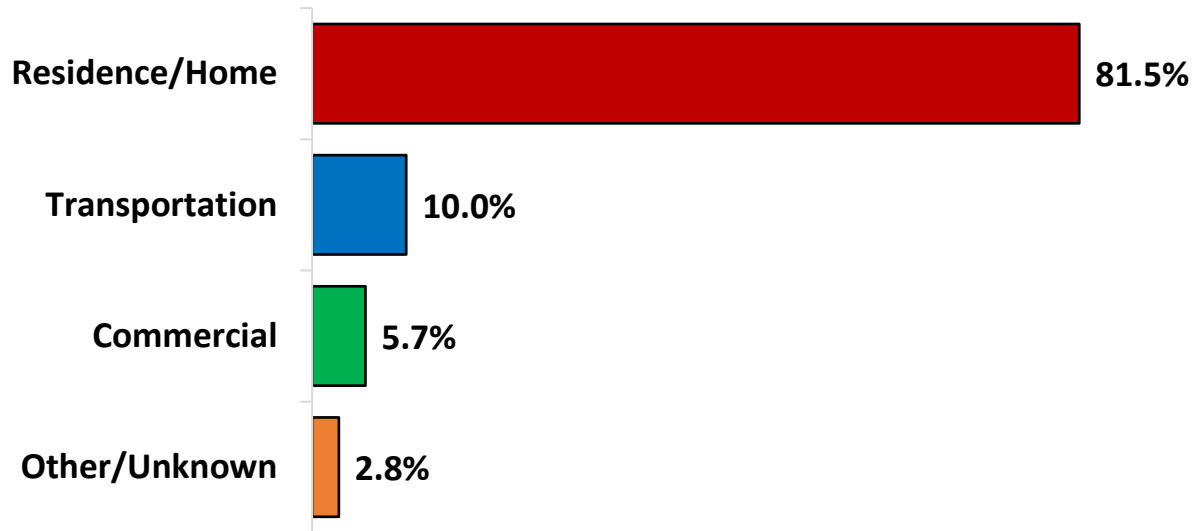
**Relationship of Victim to Offender**



- In 2020, there were 84,205 offenders of domestic violence reported to Tennessee law enforcement agencies.
- Domestic violence offenders spanned a wide range of ages, with 25 to 34 year olds accounting for the highest percentage of offenders (32%).
- The majority of domestic violence offenders (68%) were men.
- The majority of domestic violence offenders (56%) were the partner or ex-partner of the victim, while another 28% were another type of (non-partner) family member.

## Locations of Domestic Violence Offenses

The following chart summarizes the locations where reported domestic violence offenses took place in 2020.



- The majority of domestic violence offenses (82%) occurred at or near a home or residence.
- Ten percent of offenses took place in locations related to transportation, such as roads, parking lots and garages.
- Six percent of offenses took place in commercial locations such as stores, restaurants and healthcare facilities.
- Other/Unknown includes educational facilities, government/public buildings, recreational spaces, fields/woods/waterway, others and unknown.

### Impact of Covid-19 on Domestic Violence

On March 13, 2020, the U.S. declared a National Emergency to control the spread of the COVID-19 virus, and in the ensuing weeks and months, many communities' implemented large-scale stay-at-home or shelter-in-place orders. These measures exacerbated vulnerabilities of those living with domestic violence, while at the same time limiting access to support options. It has been suggested that the pandemic produced a "perfect storm" of factors contributing to increased domestic violence. Emerging data appear to support this expectation, although the associations are complex and not immediately intuitive, and many factors may combine to contribute to actual reports of violence. Reports of domestic violence to Tennessee law enforcement agencies decreased between 2019 and 2020, although the rate of decline did slow compared to previous years. Although it's not possible to say if this was the result of an actual decrease in the incidence of domestic violence or was the result of decreased reporting of these events, it should be noted that calls to domestic violence helplines in the state did increase during the early stages of the pandemic. # Technical Notes

Data Sources: 1) Tennessee Bureau of Investigation (TBI), Tennessee Incident Based Reporting System (TIBRS), and 2) Tennessee Department of Health, Division of Population Health Assessment, population estimates based on interpolated data from the U.S. Census's annual estimates of the resident population.

Numbers of victims are the total number of reported victims in 2020 or between 2016-2020, as specified in the report. The number of victims does not represent unique individuals. If an individual was involved in more than one incident within the reporting period, he or she is counted more than once. Victimization rates are for either 2020 or are the average, annual rates for 2016-2020. All rates are per 100,000 and are age-adjusted to the 2000 US Standard Population with 11 age groups. When making comparisons across groups (e.g., females vs. males or blacks vs. whites), it is recommended that 95% confidence intervals be considered (provided in the appendices). If the 95% CIs for two groups do not overlap, then the difference between them can be considered statistically significant. If they do overlap, then the difference may not be statistically significant. Comparisons made in the text of the report are all statistically significant unless otherwise specified.

The Tennessee Incident Based Reporting System (TIBRS) is used to collect crime statistics in Tennessee. Crimes are reported into the system by multiple law enforcement entities, including state, county, city and university/campus agencies. In TIBRS, a crime incident is defined as one or more offenses committed by the same offender or group of offenders at the same time and place. There are three main categories of offenses: crimes against persons, property or society.

Domestic violence offenses are considered crimes against persons flagged by the law enforcement agency as being domestically related. There are a total of 13 offense types in this report identified as domestically related in TIBRS which include:

- Aggravated Assault
- Intimidation
- Simple Assault
- Forcible Fondling
- Forcible Rape
- Forcible Sodomy
- Sexual Assault W/Object
- Incest
- Statutory Rape
- Kidnapping/Abduction
- Murder
- Commercial Sex Acts
- Stalking

The relationship between victims and offenders is reported in TIBRS as the relationship of the victim to the offender. For example, if the relationship reported is "child," then the victim was the child of the offender.

## Technical Notes *cont.*

The category "victim was offender" is used in cases where all of the participants in the incident were victims and offenders of the same offense, such as a barroom brawls where "mutual combatants" are arrested.

TIBRS allows up to two locations to be reported for each offense -- primary and secondary. For example, if an offense occurs in a restaurant parking lot, the primary location would be reported as parking lot and the secondary location would be restaurant. Analyses for this report were restricted to primary locations.

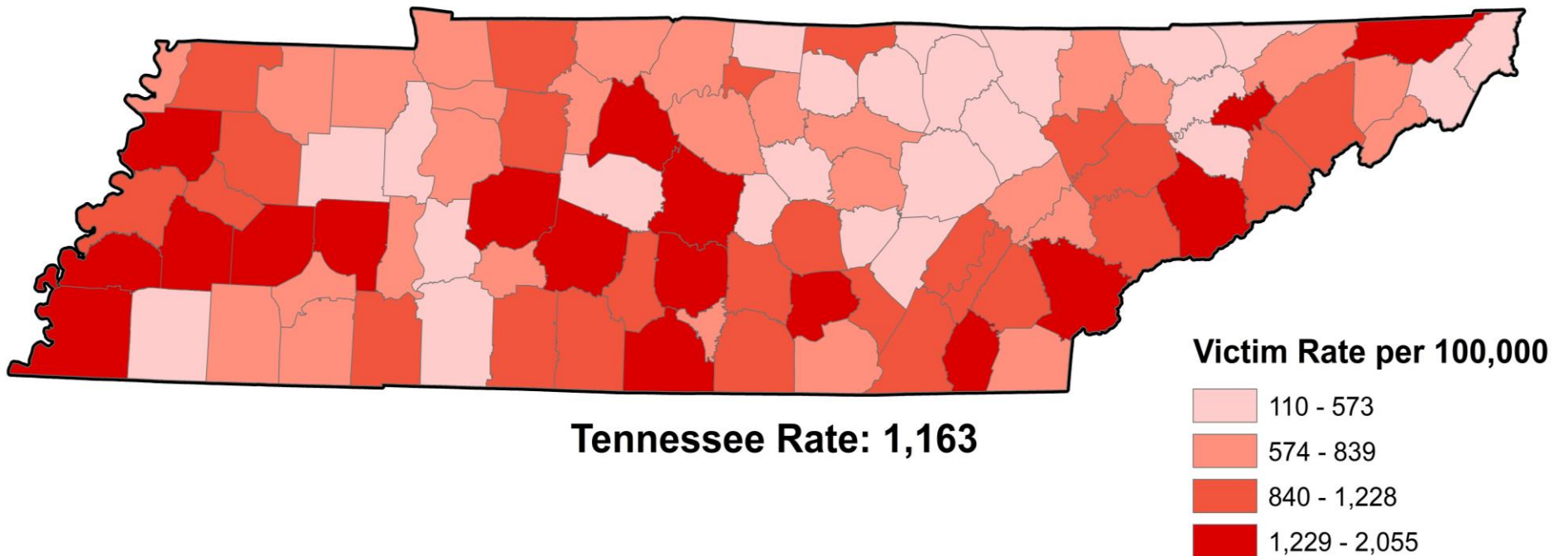
