Re: Request for Physician Waiver for Physical Medicine and Rehabilitation in Sullivan County, Tennessee

Dear Commissioner Piercey:

Ballad Health ("Ballad") has identified a need for additional Physical Medicine and Rehabilitation ("PM&R") coverage in Sullivan County, Tennessee and is requesting a waiver under Section 5.05(e) of the Second Amended and Restated Terms of Certification. The outpatient PM&R services in Sullivan County are supported by physiatrists from Ballad Health Medical Associates ("BHMA") and several independent physician groups. Currently, the BHMA physiatrists serve multiple clinics across the Ballad footprint and operate a post-COVID clinic in Kingsport. Ballad is the only entity providing post-COVID care in the region.

The most recent needs assessment shows that Ballad's market needs 3.3 to 3.7 FTEs in physiatrists by fiscal year 2023. The current clinicians are operating at 75th to 90th percentile from a work relative to value unit perspective ("WrVU") as compared to Medical Group Management Association ("MGMA") data. There are currently three independent physicians providing PM&R services in Sullivan County, Tennessee for an FTE of 2.2. These physicians primarily operate out of Bristol, Tennessee, while the newly employed physician will spend .6 of their time in the Kingsport area. The remainder of this FTE will be spent in clinics in Big Stone Gap, Morristown, Greeneville and Rogersville. This additional provider will be focused on spine and rehab and will not affect the independent physicians as they are embedded in orthopedic and neurosurgery clinics.

The addition of this provider will significantly cut down on wait times for patients needing to see a pain specialist. The current appointment wait time is over two weeks, and we believe that some of these patients are seeking care at emergency rooms rather than waiting for appointments. Another consideration is the current rise of COVID cases in the region. The addition of the post-COVID clinic is also impacting the availability of providers to see patients in a timely manner. These patients require additional follow-up appointments to track their progress and treat their post-COVID symptoms and

conditions. The average appointment time for these patients is typically longer, with a post-COVID patient taking up to three 15-minute appointment slots each visit. As COVID numbers continue to grow across the region, we anticipate more patients will be utilizing the post-COVID services offered.

Due to these factors, Ballad is respectfully requesting a waiver under Section 5.05(e) of the Second Amended and Restated Terms of Certification to add an additional .6 FTE to Sullivan County, Tennessee to ensure adequate coverage is available, to keep patients out of the emergency room and assist with COVID-19 patients.
