RE: Restated 35% Wavier as of January 31, 2018

Mr. Levine,

This is in response to your letter dated March 3, 2022 in which you restate the original numbers (Full-time equivalents and corresponding percentages) for a previously granted waiver to accurately reflect the employed physicians that were in place as of January 31, 2018. The January 31, 2018 waiver ("Employed Physician Waiver") permitted Ballad Health ("Ballad") to employ the stated concentrations of physicians by designated specialties above the limitation contained in the then-current version of Section 5.05(e) ("35% limitation") of the Second Amended and Restated Terms of Certification, dated April 27, 2021 ("TOC"). Since that time, Ballad has sought, and the Tennessee Department of Health ("TDH") has granted, additional waivers of the 35% limitation which have altered some of the permissible percentages.

The Employed Physician Waiver of the 35% limitation was specifically addressed in the verbiage of Section 5.05(e). The most recent version of the TOC contains a 35% limitation for each of Sullivan and Washington County, Tennessee but does not limit the number of employed specialty physicians at individual hospitals nor limit physicians practicing at hospitals in other counties within the Ballad geographic service area.

TDH recognizes the need of patients for physicians and surgeons with specialized training, and it was the intent of TDH at the time of signing the TOC to retain then-current staffing levels but to limit the expansion of the percentage of Ballad employed physicians practicing at certain Ballad hospitals. TDH understands that your letter was intended to clarify the numbers and percentages of physicians practicing at Ballad facilities within the relevant counties and not to alter the numbers and percentage. Further, I understand that you have reviewed your recalculations with the COPA Monitor.

TDH appreciates Ballad's efforts to provide the most accurate and complete information about employed physicians to TDH and to the public. Therefore, the restatement is accepted, and Ballad is granted a permanent waiver, effective retroactively as of January 31, 2018, for the number and percentage of specialty physicians practicing in each of Sullivan and Washington County as stated in your attached letter of March 3, 2022.

Thank you for your continuing efforts to serve the needs of your patients. TDH is confident that affirming these waiver requests will provide benefits to residents in the region in the form of improved access and outcomes. Ballad's success is imperative to the residents of Northeast Tennessee and Southwest Virginia, and we want to do our part to help make that success possible.
