The CMS Atlanta Regional Office has reviewed your civil money penalty (CMP) request seeking \$493,550.87 to purchase "It's Never Too Late (iN2L) adaptive computer technology for ten skilled nursing homes. This is a three-year CMP project entitled, "Activities, Restorative, and Therapy in Sync (ARTS). The participating nursing homes are:

- VanAyer Healthcare and Rehab Center, Inc.

Congratulations, CMS has approved the usage of CMP funds to purchase iN2L computer technology. CMP funds are being allocated for the ARTS three-year project. Acceptance of CMP funds by each nursing home, Tennessee Health Management (THM), Inc., and American Health Companies, Inc. requires THM to submit quarterly reports on the status of the ARTS project in each of the ten nursing homes. THM shall provide CMS with a copy of the written contract with the state regarding this project and CMP funding. The facility shall be responsible for all costs

associated with the iN2L system at the conclusion of the three-year project, including maintaining subscription and training costs, and related fees for internet access.

Quarterly reports shall include a cover letter with the name of the facility; the name of the project leader, along with their telephone number and e-mail address; the CMS Certification number, and the CMP request number 2017-04-TN-0608 on all pages of the report and narrative.

THM shall submit an annual report prior to the release of funding for the second and third years of the project. THM shall also submit a final report at the conclusion of the three-year project that discusses best practices in resident care resulting from using iN2L adaptive computer technology and the "Activities, Restorative, and Therapy in Sync" project.

This CMP request was made possible by the Centers for Medicare and Medicaid Services (CMS) in partnership with the Tennessee State Survey Agency.
